• Chairman Gerentine called the meeting to order at 5:35 PM

Motion No. 1: To discuss Resolution No. 197, As Amended – Establishing A Policy To Limit Participation In Party Politics By Appointees Of Ulster County Elected Officials

Resolution Summary: This Resolution establishes a policy to prohibit disclosed positions within Ulster County from holding any position of authority within any political party and prohibiting disclosed positions from making a contribution of any sum of money to any committee on behalf of any candidate for an Ulster County elected office.

Discussion: Legislator Joseph Maloney explained that the Board of Elections

has been removed from the purview of the Resolution and that he intends to remove the clause "...would directly protect Ulster County residents from corrupting forces" from the Resolution. Chairman Gerentine expressed concerns with the Resolution, stating that he believes it does a disservice to the volunteers that serve Ulster County. Discussion pursued on the variances between

the proposed policy and that which was adopted by Nassau

County. Legislator Bartels affirmed agreement in the intent of the Resolution but expressed concern over the inclusion of volunteers.

Legislative Counsel, Nick Pascal confirmed that the proposed policy does cover all appointees which would include volunteer board members. Further, Nick Pascal disclosed Counsels' concerns over the proposed form of the policy, stating that the intent is most appropriate in the form of an amendment to the ethics law as opposed to a Resolution, that local party official has not been defined therein, and that the policy does not appear to apply to prospective appointments. Discussion pursued on the difference between the two forms of presentation. Legislative Chairman Ronk stated respect for the intent of the Resolution, but admitted ideological concerns, stating that political speech and participation in the political process in the way that an individual sees fit is one of the hallmarks of democracy, and that he disagrees with the assumption that serving in the included capacities is a conflict of interest. Legislator Joseph Maloney asked that Committee members consider the effects of the policy on a Federal level. Marc Rider, Deputy County Executive, stated that the intent of the Resolution takes away the rights of American Citizens to participate in the democratic process. Legislator Rodriguez affirmed support for the intent of the Resolution. Legislator Bartels stated discomfort in making last minute amendments to the Resolution, expressing desire to make sure all respects of the policy are as intended prior to voting. Legislator Joseph Maloney requested that all concerns be presented to him prior to the next meeting of the Committee.

Resolution Summary: This Resolution amends Capital Project No. 334 – Kingston Rail Trail (PIN 8758.04) to appropriate an additional sum of \$60,000.00 to cover the cost of participation in the right-of-way acquisition phase of the project, authorizes the Chairman of the Legislature to execute all necessary agreements, certifications, and reimbursement requests for federal aid on behalf of Ulster County with the New York State Department of Transportation ("NYSDOT") in connection with the advancement or approval of the Project and providing for the administration of the Project, and amends the 2019 Ulster Capital Fund Budget accordingly.

Legislative Chairman Ronk explained that he has appointed Legislator Maio to the Ways & Means Committee. Discussion pursued between Legislative Chairman Ronk and Legislator Bartels on the balance of power. Chairman Gerentine congratulated Legislator Maio and stated that she is an asset to the Committee.

Legislator Archer explained to the Committee that she has been working with Chairman Gerentine to create a recommendation to enhance the budget process which is intended to prompt conversations and improve Legislative comprehension of the County Executive Recommended Budget. Chairman Gerentine commended Legislator Archer on her hard work, noting that the County Executive must concur with the recommendations proposed. Discussion pursued on what changes will potentially be included within the recommendation.

Legislator Greene explained to the Committee that the Green Business Challenge is officially ready to be launched and that a breakfast will be hosted for businesses on Wednesday, June 27th at 7:30 am at the Best Western and that preregistration is available. Further, Legislator Greene explained that at the breakfast case studies will be presented by Green Business Leaders, green experts will be available to converse with, there will be a vendor show, and information will be available on the existing incentives and financing available for businesses wishing to take green initiatives.

Chairman Gerentine asked if there was any other business or questions. There being no further business before the Committee, a motion was made to adjourn.
