Motion No. 3: To approve Resolution No. 301 – Creating One Full-Time Position And Amending The 2019 Ulster County Budget – Office For The Aging

Resolution Summary: This resolution creates one new position in the Office for the Aging and amends the 2019 Ulster County Budget.

Discussion:	Legislator Maloney requested the list of employees that are funded by outside sources. Burt Gulnick, Commission of Finance, is working with Personnel to try to create a report. Legislator Maloney expressed that Finance should have a list ready to go if they are tracking it. Legislator Rodriguez pointed out that there are different funding sources that can end at different points during the year. Legislator Rodriguez suggested that a position may not get cut mid-year, but the legislature would need to be notified for the following budget year. Legislative Chairwoman Bartels asked for the legislative staff to begin tracking this going forward. Chairwoman Archer requested some time to work with Finance and to create an internal process.

	Legislator Maloney pointed out that the position would not be created without grant money and creating a policy to eliminate the position when the funding disappears puts the County in a position of re-hiring someone and creating a position instead of firing and eliminating their position. It was determined that the standard sunset language had no effect as it is overridden by the budget process.

Motion No. 4: To approve Resolution No. 295 – Approving The Execution Of A Contract In Excess Of \$50,000.00 Entered Into By The County – Securus Technologies, Inc. – Ulster County Sheriff

Resolution Summary: This resolution approves the execution of a contract with Securus Technologies, Inc. at a minimum of \$750,000 (\$250,000 annually) for August 20, 2019 – August 19, 2022 to provide inmate communication services.

Discussion:	Legislative Chairwoman Bartels wanted to clarify the cost to the inmate is \$0.14 per minute for phone calls and \$5.00 per month for tablet use. Undersheriff, Jon Becker, confirmed that the price per minute is being reduced from \$0.22 to \$0.14. The \$5.00 tablet charge is for the expanded use of the table, the educational information is free, and every inmate receives a tablet.
	The Securus representative, Daniel McGuinn, explained that the free tablet is set up to help the inmates. The content includes a law library, GED prep, plus local college and trade school programs. It also includes messaging capabilities, but a fee will apply. The inmate will purchase "stamps" which are sold in books of 5. One text message is equal to one stamp or \$0.50.
	Legislator Petit questioned the security of the tablet. Daniel McGuinn explained that everything is saved and available to perform key word searches for language or terms.

Legislative Chairwoman Bartels asked about the book content. Daniel McGuinn explained that there are Religious materials, mental health, and drug addiction materials as well as public domain books.

Legislator Maloney stated that the County is expected to profit approximately \$300,000 from this contract. Legislator Maloney asked Daniel McGuinn how this compares to other municipalities of similar size. Daniel McGuinn explained that it is a proposal to maintain or expand the current revenue base while reducing costs to inmates and increasing the availability of services. The tablet and voicemail services are functions not available today. The addition of these will likely be an added source of revenue. The movie and game features will fund the free applications. The purchased content will also remain on their account if they do end up returning to the facility, apart from movies, they are equivalent to two-day rentals.

Legislator Maloney questioned the ability to make the services more affordable and to decrease the profit made on the contract. Undersheriff, Jon Becker, explained that this contract passes on some of the savings to the inmate by dropping their call price from \$0.22 to \$0.14 per minute. Legislator Rodriguez asked if there was a way to bring calls all the way down to free for the inmates. Jon Becker explained that, today, most of the revenue is expected to come from phone calls. Legislator Maio asked what inmates in other Counties pay. Undersheriff Becker explained that most inmates pay \$0.22 and Ulster County would be one of the lowest in the state with the \$0.14 per minute contract. For reference, Albany County is at \$0.23 per minute.

Legislative Chairwoman Bartels expressed concern over profiting from inmates as well as the equity of prisoner's where one may have the ability to afford a movie, and another may not. Legislative Chairwoman Bartels was also concerned about the quality of the law library.

Legislator Gerentine clarified that it is a 3-year contract with two extensions. Legislator Gerentine also questioned the decrease of inmates over the last year and if that was considered for the annual revenue calculations. Discussion continued regarding how Securus is taking less profit than the previous contract, therefore increasing Ulster County's percentage of the profit per call. Legislative Chairwoman Bartels also reminded the committee of the new revenue source; movies and games. Legislative Chairwoman Bartels asked if there would be an annual report with a breakdown

	of movies rented etc. Daniel McGuinn explained that there will be a monthly extract with this information.
	Legislator Rodriguez questioned if the extensions were able to be renegotiated. Daniel McGuinn stated that he had no problem negotiating throughout the term of a contract and would write that in the current contract. There was no need to wait three years to renegotiate.
	The group tabled the discussion to verify if there was an escape clause in the contract.
	Legislator Rodriguez explained to the committee that under article 28 the County can terminate the contract.

ACA PUBLIC CORRECTIONAL POLICY ON FAMILY-FRIENDLY COMMUNICATION AND VISITATION

Introduction:

Regular communication between offenders and their family and friends is proven to aid the reentry process and is consistent with sound correctional management.

Policy Statement:

Correctional agencies should promote communications between offenders and their family and friends and adopt family-friendly policies that:

A. Allow visitation, correspondence, phone calls and multiple forms of audio and visual communication;

B. Use emerging technologies as supplements to existing in-person visitation;

C. Do not place unreasonable financial burdens upon the offender or their family and friends;

D. Grant access to a range of reasonably priced telecommunications services that comply with all applicable state and federal regulations;

E. Establish rates and surcharges that are commensurate with those charged to the general public for like services and that any deviation from ordinary consumer rates should reflect actual costs associated with the provision of services within a correctional setting; and

F. Provide the broadest range of telecommunications options determined to be consistent with the requirements of sound correctional management.
