Discussion:	Legislator Bartels explained that she spoke with Commissioner Iapocci who informed her that the Department of Social Services has always participated in supervised visitation, it is his understanding that this program is used for private custody matters, and the court sees this as a valuable service, especially for families who do not have the means to pay for the service. Further, Legislator Bartels vocalized desire to discuss where this service should live during the budget cycle, noting that the contract is a not-to-exceed value and, as such, is not guaranteed to cost the total value. Legislative Financial Analysts Natalie Kelder informed Committee members that Family of Woodstock submitted invoices amounting to less than \$23,000.00 in the prior year. Legislator Walter asked if the quantity of service provided during the current year is known. Discussion pursued on the services provided and the suggested contractual value by Family of Woodstock. Legislator Ronk suggested an amendment to \$20,000.00 with the understanding that Family of Woodstock can come before the Legislature later in the year if a greater value is needed in order to continue providing the service. Legislator Bartels asked why the

amendment is necessary if the Organization is only invoicing for reimbursement of services provided, noting that the difference between this suggestion and the Organization's suggestion is minimal. Legislator Ronk explained his preference is to push for greater budgetary savings in a time when the County is trying to reduce expenditures, that since the courts have been shut down with the exception of emergencies, he feels the \$20,000.00 value is safe, and that reserving the right to further amend the contract allows for flexibility to prevent the services from stopping. Further, Legislator Ronk agreed that discussion should take place on a better budget line for the services in discussion, emphasizing the need for the Legislative Contractual Appropriations policy as services that are this important should not be subject to change year over year.

Chairwoman Archer: Opposed?

Resolution 144. Or 141, excuse me, this is for supervised visit, visitation. We had previously postponed this. Legislator Bartels

Legislator Bartels: Make a motion to discuss.

Legislator Walter: Second.

Chairwoman Archer: Okay, Legislator Bartels.

Legislator Bartels: So I, I had a brief conversation with Commissioner Iapoce today. I had asked that we postpone it a month. But then given that we had the meeting today, I wanted to see if I could get some update. He said that he did some research, because obviously, Department of Social Services has always participated in supervised visitation, particularly as it's mandated by the court for those in our care and custody, for whatever reason, whether that's been through removal, or a voluntary separation.

His understanding of this program is that this program is used for private custody matters. In other words, it's in connection with private custody cases where supervised visitation is recommended, and typically, he said that the members come to agreement on who might be able to provide that supervised visitation. Sometimes it's a family member. But there are cases where they either can't come to agreement, or they don't have anyone. There's no one that they can get to provide the supervision for the visitation.

And in those cases, now, the court would refer to Family of Woodstock, and the county pays for that supervision. He said that there is an organization that does this regionally. I think it's called Bridges of Hope, he said. He said but they charge a fee. Family of Woodstock also charges a fee. It's just that we pay it. And his impression, from talking to the clerk of one of the courts, was that the court sees it as a valuable service, particularly for families who might not have the means to pay for the service.

Now, I do personally believe that we need to have a conversation in this next budget cycle of where this program will live. If we continue with it, with the county, if we continue to serve it. I don't know if that would be Social Services. It might be Department of Health, or Mental Health, or through some of the other. We'll have, we'll have to the Executive's Office about it. But, I don't at this point in time, it's not something that would be taken over by Social Services, because again, these are these are private custody cases. So, I think we should, I think we should discuss this and move on it today.

Chairwoman Archer: Are you going to make a proposal to amend the current amount?

Legislator Bartels: Yeah. Can you share the numbers that, that you had, or that Natalie got from the last cycle? And also.

Chairwoman Archer: Go ahead.

Legislator Bartels: Just as background for everyone to know was we're looking at this contract This is a not to exceed contract. They bill, I think Natalie can tell us, but I think they bill quarterly.

Chairwoman Archer: Yeah.

Legislator Bartels: And they submit invoices. So, it's not an absolute that we would spend this money. I think we're going to hear from Natalie in a minute that we didn't spend the full amount last year. So.

Chairwoman Archer: Natalie, you want to just give everyone an update of what you've surfaced?

Natalie Kelder: Sorry, I had to sum the quarterly payments. So, last year, they submitted for just shy of \$23,000. And then.

Chairwoman Archer: They had an up to up to \$25,500, correct?

Natalie Kelder: I have, yes, \$25,500.

Chairwoman Archer: And this year, this year there was language added in the program, where we're asking them to tell us by month, the number of families that were assigned, the number of visits that were set up, and the number of visits that were conducted per month, correct?

Chairwoman Archer: Legislator Walter.

Legislator Walter: Yeah, I guess I have a question about that, especially with COVID. And most of the courts being closed. Do we know what the last three months have looked like? You said we get quarterly reports?

Chairwoman Archer: We didn't get anything this year because this is this year's contract that we're discussing.

Legislator Walter: Oh. Right.

Amber Feaster: Submission is part of their invoicing. So, they wouldn't have invoiced us for a period that there's no executed contract for.

Chairwoman Archer: Now, we did hear, and Tracey, you may have heard this, that there was limited Family Court, but it's not the usual full docket. Is that correct?

Legislator Bartels: Well, I didn't hear that from Commissioner Iapoce. I heard that anecdotally.

Chairwoman Archer: Oh, okay.

Legislator Bartels: From people in my life. So, I couldn't, I couldn't 100% confirm that or whether or not that was just their experience of it.

Chairwoman Archer: Legislator Haynes.

Legislator Haynes: But wouldn't there still had been continued visitation?

Chairwoman Archer: With this, with the Family of Woodstock?

Legislator Haynes: Even during COVID. If, if, if these monies are going towards supervised visitation, wouldn't there have continued, I can't imagine a parent waiving their rights to visitation even during a pandemic.

Chairwoman Archer: I can't, can't speak to that. Legislator Walter.

Legislator Walter: Yeah, I feel like maybe, given this information, I mean I don't want to postpone it. But at the same time, you know, like, I don't know if this is a cumulative. Whether this just provides services for the first set of visitations. Because if it was a cumulative for all visitations, then it would just get bigger and bigger. So, it might be worth knowing a little bit more about how much they've served over the last three months. And whether the courts were even operating in this way.

Chairwoman Archer: Did we get a response? I'm sorry, did we get a response from Family of Woodstock on this? I don't have it before me.

Legislator Walter: Isn't this the one that they suggested that they dropped down to, or maybe that was a different one. One of them, Family had sort of suggested a cut but.

Legislator Bartels: This is the only one in this packet, I think.

Legislator Walter: Okay. So, they suggested a drop down. I have written in my notes that they suggested a drop down to \$7,500. But that doesn't sound... a drop down of \$7,500. Maybe that's what they said in their notes.

Legislator Maio: I have it here, you're right Eve, it says to drop it by \$7,500, to make it \$22.5K.

Chairwoman Archer: Okay. Does somebody want to make an amendment?

Legislator Ronk: Lynn, can I be recognized?

Chairwoman Archer: Oh, I'm sorry. I didn't see your hand up there.

Legislator Ronk: That's okay. It's in the blue. It's tough.

Chairwoman Archer: It's dark. Yeah, sorry.

Legislator Ronk: It is yeah, I'm backlit here, which is a problem. Here if I turn this way, you'll be able to see me better

Chairwoman Archer: Oh, much better.

Legislator Ronk: I'll just, I'll hold the computer. So, what, remind me, because I think I was on my ambulance call when we went through this, you know, at Ways and Means. What was agreed on by the committee?

Chairwoman Archer: We had postponed it, waiting further information from Iapoce, which that's what Tracy just shared with us.

Legislator Ronk: Okay. What was the original amount without me pulling it up?

Chairwoman Archer: \$30K.

Legislator Ronk: \$30K?

Chairwoman Archer: Yeah.

Legislator Ronk: At this time, here's my proposal. I make an amendment that we drop it to \$20,000, but reserve the right for them to come back to us later in the year and justify an increase if there's more visitation. That would be my proposal.

Chairwoman Archer: Is there a second?

Tracey?

Legislator Bartels: Well, I'll second it for discussion and then may I comment?

Chairwoman Archer: Yes, please.

Legislator Bartels: I mean, I'm just curious, Ken, aren't they, wouldn't they be coming back to us, just through the course of the contract, with these new details be given that they bill 1.) they bill quarterly; and 2.) they bill as they use it?

Legislator Ronk: Yeah.

Legislator Bartels: So, if there's more visitation, that you know what I mean, they're gonna, Last year than in use the full funding. So, I feel like they're going to come to us anyway. I mean, the difference between what they're asking for which is the \$7,500 cut to a \$10,000 cut, I think is minimal. You know, I'd almost sooner go with their \$7,500 cut for this year. But I really do want

us to look closely at this program and see where it could live in an executive budget. If in fact, we determined that it is worthy to move forward with. Because again, we're you know, we're funding private custody cases, which isn't necessarily a bad thing, but I think we do need to really understand that, and have it, have it looked at somehow, departmentally.

Chairwoman Archer: Legislator Ronk.

Legislator Ronk: Thanks. You know, my going a little above their number or, you know, for a cut is mainly because, you know, I think that they're probably not going to use the whole amount that they've asked for either. And I would rather, you know, keep less in the budget when we're trying to cut then put more in knowing that they're probably going to come in under budget again. Especially since the courts have been shut down except for in emergencies.

And from what you've said, Tracey, about what Mike Iapoce said, and the fact that even last year they came in under budget, with a full year of visitation. I feel like the \$20,000 dollars is safe. And then, you know, the reserving the right is, you know, no one wants, you know, the visitations, you know, to have a gap or something like that. So, again, with the quarterly reporting, if we notice that there's a higher number than normal visitations, the Legislature can always put it back in. You know, that's, you know, that's our that's our right here.

I don't know, I just think that, I definitely agree with you that we should look for a place to put this in the budget as a whole.

But I also think that this highlights the need for, you know, Legislator Petite, and I, along with Legislator Walter, and others who have interest, to work on the policy for funding these organizations. Because, again, this seems like something, that if it's this important, should be a regular line the budget and shouldn't be, you know, subject to the will or whims of, you know, a majority of members on this committee or a majority of members in the legislature.

Chairwoman Archer: Legislator Haynes.

I just happened to look it up. Under the Family of Woodstock website. It says visitation is has now been moved to the Everett Hodge Center. This happened last fall. And the program typically works with five to eight families each month. And last year, they actually hired two extra staff to help facilitate so that there wasn't a backlog waiting, so that there wasn't a waiting list.

Chairwoman Archer: Okay. Right. So, on, there's amendment before us to amend to \$20,000.

All in favor?

Group: Aye.

Chairwoman Archer: Opposed?

Legislator Bartels: I'll, I'll, I'll, concede the \$10,000. As long as they have the opportunity to come back to us overall.

Legislator Walter: Yeah. I will.

Legislator Archer: Yeah. Can we make that caveat in in the contract?

Legislator Ronk: I did in my motion.

Chairwoman Archer: Okay. Oh, Okay, great.

Legislator Bartels: I think we'll just want, we'll need to communicate that to them, and to our caucuses, that stipulation.

Legislator Ronk: Yes.

Chairwoman Archer: Okay. All right.

Resolution 142. This is the Dispute Resolution Center. Motion to approve 142 as amended before you.

Legislator Ronk: I'll move it, as amended.

Chairwoman Archer: Second?

Legislator Bartels: I'll second it.

Chairwoman Archer: Okay, all in favor?

Group: Aye.

Chairwoman Archer: Opposed?

I need to go back to 141, I needed to do the two-step and I only did the one-step. So, we approved the amendment. Now, we have to approve, adopt the resolution as amended.

So, on resolution 141, can I get a motion?

Legislator Ronk: I'll move it.

Chairwoman Archer: And the second? Maio.

All in favor?

Group: Aye. Aye.

Chairwoman Archer: Opposed?

Okay. Thank you.

Chairwoman Archer: Resolution 143. This is Ulster County Performance Art Center. This is a motion to approve Resolution 143, as amended before you.

Legislator Ronk: I'll move it as amended.

Chairwoman Archer: Second? Mary Beth Maio. Okay.

All in favor?

Group: Aye. Aye. Aye.

Chairwoman Archer: Opposed? So moved.

Any new business anyone?

Legislator Gavaris: Lynn, Lynn. I was opposed on that one.

Chairwoman Archer: Oh, you're opposed. Okay. I apologize. I didn't catch your hand.

Legislator Gavaris: Yes. It's okay. I also missed some of them before. I had problem with the PDF I couldn't open it. So, I did unfortunately vote yes earlier where I meant to vote no on some, but that's okay. It's fine.

Legislator Ronk: Before the meeting is adjourned, you can change your vote.

Chairwoman Archer: Did you want to change your vote before? I'm sorry?

Legislator Ronk: I said, before the meeting's adjourned, he can change his vote.

Chairwoman Archer: I understand. That's what I was just going to say to him. Is there a vote you'd like to change, John, before we close the meeting?

Legislator Gavaris: I just got this PDF open. So, let me go back because I didn't, I had it in my email and I didn't open it. So, I've got it now. Give me a second.

Chairwoman Archer: Okay, which resolution is it? Okay.

Legislator Gavaris: Lynn, never mind, go ahead. It's fine. It's fine.

Chairwoman Archer: You're okay. So, you're only opposed to the last one, 143?

Legislator Gavaris: It's fine, yeah.

Chairwoman Archer: Any new business?

Legislator Ronk: I move we adjourn.

Chairwoman Archer: Okay. Second?

Legislator Gavaris: Second.

Chairwoman Archer: All in favor?

Group: Aye.

Chairwoman Archer: Thank you, everyone, see you on the 30th.
