#### **Budget Director Juras:**

**Proposed CP Amendment No. 1** - Balance Bus Shelter Revenues and Expenses - Amending the Capital Improvement Program to adjust Galeville Bridge Replacement to reflect expenses based on opened bid documents. A resolution was passed in November of 2023 to reflect these costs.

**Proposed CP Amendment No. 2** - Adjust Timeline of Government Operations Center - Amending the Capital Improvement Program to adjust the Bridge Substructure Repairs Project to reflect expenses for Leggs Mills Bridge and Rosendale Bridge based on opened bid documents. A resolution was passed in November of 2023 to reflect these costs.

**Proposed CP Amendment No.** 3 - Balance and Increase Mount Marrion Traffic Signal - Amending the Capital Improvement Program to add construction for the Bridge Superstructure Repairs Project to 2024. Bridges to be considered at this time are the Watson Hollow, High Falls, Coxing, Saugerties Reservoir, and Tuttletown Bridges.

**Proposed CP Amendment No. 4** - Inclusion of Law Enforcement Technology Program - To remove the Open Space and Recreation Program from the Capital Improvement Program. The Program has yet to be established but has appeared in historic Capital Improvement Programs. The Program is designed for open space protection, farmland preservation, and explanation of public recreational opportunities. The County established an Agricultural Service Administrator position in 2024 which is designed to create a program similar to this.

**Proposed CP Amendment No. 5** - Increase Expenses & Balance Revenues for Solar Array-Bridge Substructures are a primary structural element for all bridges. Ulster County is aware that it owns several bridges which have deteriorating substructure which support superstructures that are in fine condition. In 2024, two (2) bridges were repaired (Rosendale and Leggs Mills). The Capital Improvement Program should separate out which bridges are intended to be repaired for each of the years included. These repairs are expensive and

materials contain lag times so the information should already be known. The Capital Improvement Program should be reflective of the correlating Resolution which is forthcoming establishing the project(s).

**Proposed CP Amendment No. 6** - Multiple Errors within Axon Body Worn Cameras - Quoting was requested and has been received for an upgrade to all Camera Systems. This amendment adds the Capital Project for the acquisition of new security cameras to County Buildings in 2024.

**Proposed CP Amendment No. 7** - Revenue Reclassification for Turnwood Bridge - This Amendment adds the Reuse Innovation Center to the Capital Improvement Program. The County has budgeted and contracted for the Reuse Innovation Center Feasibility Study and it is foreseeable that the Reuse Innovation Center Project will be undergone, therefore, it should be part of the County's 5 year plan.

# **Legislative Chair Criswell:**

Proposed CP Amendment No. 8 – Inclusion of Established Bridge Projects - This amendment adds the Maple Avenue Sidewalk Replacement Project to the Capital Improvement Program. Ulster County has recently prioritized it's outdoor spaces through trails and parks initiatives, as well as it's environmental initiatives. Sidewalks play a vital role in both of these initiatives by establishing safe alternative transportation methods and creating rural trails. The Maple Avenue Sidewalk is in need of repair and a quote has already been prepared for the work necessary. There are several Federal grants currently available to fund sidewalks. For example, the Transportation Alternatives Program (TAP) authorized under Section 1122 of Moving Ahead for Progress in the 21st Century Act (MAP-21) provides funding for programs and projects defined as transportation alternatives, including on-and-off-road pedestrian and bicycle facilities, infrastructure projects for improving nonmotorized access to public transportation and enhanced mobility, community improvement activities, and environmental mitigation; recreational trails projects; Safe Routes to School projects; and projects for the planning design or construction of shared-use pathways and sidewalks. Moreover, the Recreational Trails Program is a program is a State-administered Federal assistance program to provide and maintain recreational trails and trail-related facilities for both motorized and nonmotorized recreational trail uses. This is a federal-aid (80/20) reimbursement program. This program is administered by the New York State Office of Parks, Recreation & Historic Preservation (OPRHP).
