Resolution Summary: This Resolution declares Ulster County's intent to act as lead agency under New York State Environmental Quality Review Act (SEQRA) for the construction of a governmental operations center to be located at Paradies Lane in New Paltz.

Discussion: Legislator Walter acknowledged the additional information that was provided

to the committee but questioned the significant price increase. Deputy Executive Kelly explained that the original cost amount is an estimate and

costs have been rising.

Chairman Gavaris pointed out that construction costs have decreased over the last six months. Deputy County Executive Kelly clarified that the cost estimate was done in-house with the Department of Public Works employees and the current numbers are from a designer. In addition, they are going to pursue funding that will cover the increased cost.

Legislator Walter stated that she would like the opportunity to review the projected funding for this project.

Legislator Ronk said he would support a postponement for the cost concerns and would prefer to better understand the costs associated with this project before getting too far into the project.

Nate Litwin, Director of Recovery and Resilience, noted that a postponement is an opportunity to provide further clarification but mentioned that the design, estimating, architecture and engineering documents are all items that the potential funding sources associated with the Homeless Housing Assistance Program would like to review.

Comptroller Gallagher provided a brief update on sales tax, stating that the county is up 9.29% over the same period for 2021 and a sale tax report will be issued shortly. Occupancy tax is currently at 55% of the county's 2022 budget and only includes the first quarterly filing. Comptroller Gallagher also shared that \$392,000 in interest was earned partially from \$103 Million that was moved to a deposit plus account. However, if those funds had been invested in NYCLASS Prime an additional \$95,000 could have been earned. Additionally, some deficiencies in bank reconciliations have been identified and a memo is forthcoming. Finally, Comptroller Gallagher shared that her office mapped all broadband within Ulster County and has identified 1,100+ unserved addresses in Ulster County. Discussion ensued on the broadband mapping, funding, and number of unserved addresses.

Chairman Gavaris asked if there was any old or new business.
