Chairman Gavaris called the meeting to order at 5:01 PM

President of SUNY Ulster Dr. Alan Roberts spoke from 5:01 PM to 5:27 PM providing an overview of the College's achievements over the 2020-2021 fiscal year, including the turnover to online learning, progress on Capital Improvements, new programs and certifications that the College is offering, and the continuation of the Presidential Scholarship.

Vice President of Administrative Services of SUNY Ulster Jamie Capuano spoke from 5:27 PM to 5:34 PM providing an overview of the upcoming year's proposed budget, emphasizing

that there is no tuition increase or staff layoffs proposed, that Federal money is providing the College with exciting opportunities, and briefing the Committee on changes to enrollment levels.

Dr. Roberts and Mrs. Capuano answered Committee questions from 5:34 PM to 5:39 PM and thanked the Committee for their ongoing support.

Resolution, including the mid-year budget increase, the fact that the work is already being completed, and the flow of reporting within the Department of Budget as they relate to the salary

requested. Legislator Ronk noted that this position is being created to promote the Deputy Director of Budget, questioning if that position will then be hired into. Legislator Walter stated she has concerns when job titles and salaries are changed mid-year without

Legislative approval.

concerns over voting on a high-level plan and then being held liable to account for the details at a later date, emphasizing desire to communicate the Legislature's requests for the funding. Legislator Walter stated that the proposed dollar values give her

discomfort, questioning where the values came from.

Motion No. 7: To postpone Resolution No. 323 – Supporting The Recommendations Of The Recovery And Resilience Working Group For Utilization Of The American Rescue Plan Act (ARPA) Funds – Department Of Finance

Resolution Summary: This Resolution resolves that the Legislature supports the recommendations of the Recovery and Resilience Working Group and urges the County Executive to direct resources of the Executive staff towards implementation.

Discussion: Legislative Chairman Donaldson emphasized that the Legislature

has final approval over the individual components of the plan and their associated expenditures as they are brought forth in the form of Resolutions. Legislator Parete stressed the importance of the funding and its potential effects on the community. Legislator Walter questioned why Inequality does not have its own heading within the plan when it's one of the most important aspects of the funding's intended usage. Chairman Gavaris asked if postponing

the Resolution delays any of the projects. Deputy County

Executive John Milgrim answered that the plan is merely a target and does not affect the projects. Deputy County Executive Evelyn Wright stated that she needs to have a team in place to begin working on the plan and that postponing Resolution No. 324 will

delay the projects included in this proposed plan.

Discussion: Legislator Ronk stated he has concerns about the salaries

requested, arguing that the salary proposed for the Director of Recovery & Resilience feels disrespectful to the Commissioner of Finance and disingenuous in nature. Further, Legislator Ronk suggested reviewing comparable positions within the County for salary considerations. Legislator Walter asked if the additional staff is necessary as the proposed use of the American Rescue Plan Act Funds is largely an extension of work that's already being completed by current staff. Legislator Walter also noted that without a spending plan in place, staffing needs cannot truly be determined as departmental staffing needs may be altered by the plan. Legislative Chairman Donaldson argued that the County needs to start moving on the plan and doing so requires these additional staff members. Discussion pursued on the appropriateness of the pay scale proposed in relation to the lines of authority within the Department, the sunset clause, and amending the Director's salary. Legislator Bartels questioned the 5% target

for administrative overhead, noting that projects are directly correlated to overhead needs. Legislator Walter requested confirmation that the cost of administration is an approved cost which is eligible for reimbursement.

that he will not vote in favor of the Resolution without an

adjustment to the salary levels. Deputy County Executive John Milgrim argued that the salary should be at a higher level than the Commissioner of Finance because the Commissioner's position does not sunset. Deputy County Executive Evelyn Wright suggested that the Director position should be housed within the

suggested that the Director position should be housed within the County Executive's department, stating that it was placed in finance because of the Director's involvement with the financial system but that the Director will report to the County Executive. Legislator Ronk requested the positions be housed in a Department that is transparent to the taxpayers. Legislator Walter noted that this is a scenario where a person is being moved and the position is being paid an annual salary based on the individual, not based on

the duties being performed.
