Motion No. 2: To approve Resolution No. 322 – Establishing New Fees For Parking At The County Office Building

Resolution Summary: This Resolution adjusts the fees to park in the parking lot at the Ulster County Office Building from $0.75/1^{st}$ hour plus 0.35/additional hour to a maximum of 3.00 to $1.00/1^{st}$ hour plus 0.50 for each additional hour to a maximum of 5.00, effective September 4, 2018.

Discussion:	Legislator Bartels confirmed that no fee is charged to park at the Courthouse. Marc Rider, Deputy County Executive, explained that it would cost the County more money than it would make to charge for parking at the Courthouse but that the County building is able to cover its costs. Legislator Bartels expressed concern over the availability of parking at the Court for individuals doing business at the facility, requesting an analysis of what the County building costs and if people parking in the Court lot are using the parking lot for purposed related to the Court of if they're going to a nearby facility. Legislator Archer inquired if the County Building's parking lot is intended to be utilized by individuals conducting business within the County Building or if it's intended for anyone regardless of where they are doing business and if it is possible to designate the lot for County-building use only. Marc Rider confirmed that the lot is currently a municipal lot. The Committee requested an analysis of where people are doing business when they park within the County building lot. Discussion pursued on the availability of parking at the aforementioned facilities.

Motion No. 14: To approve Resolution No. 345 – Authorizing The Chairman Of The Ulster County Legislature To Convey The Poor Farm Reservoir Property, Tax Map No. 86.1-1-41, To The City Of New York Without Consideration Pursuant To Section 72-h Of The New York State General Municipal Law – Department Of Public Works

Resolution Summary: This Resolution authorizes the Chairman of the Legislature to convey the included property in fee to the City of New York without consideration, excepting only that the City of New York shall pay all costs associated with or required for said conveyance, with all rights reserved within the deed.

Discussion: Marc Rider, Deputy County Executive, explained that the included property is located near the Mohonk Preserve and the Department of Environmental Protection's (DEP) aqueduct, that the property was historically used as a water supply for the Poorhouse and more recently for the Fair Grounds, and that a few years ago the County had a water system put in for the Fair Grounds so the property is no longer in use. Further, Marc Rider expressed that the property is considered a liability for the County and that the DEP has requested the land. Legislator James Maloney inquired of a stone structure on the property. Marie Bing, Esq., Assistant County Attorney, stated that a dam was built on the property but that it was destroyed because people were using the pond as a swimming hole and liability became a concern so the structure may be remnants of the dam. Legislator Petit said that the Town and Village of New Paltz have been looking for water sources, asking if the County has approached these municipalities to see if they were interested in it. Marc Rider answered that since dam has been removed from the property he's not sure that it is much of a water source and that the DEP only wants the property because of its location in relation to the DEP's aqueduct. Legislator Archer asked if anyone has spoken to New Paltz. Marc Rider answered that he is not aware of any discussions with these municipalities. Legislator Bartels noted that some of Mohonk Preserve's trails are on the property, asking why the County feels it's necessary to complete this transaction. Marc Rider said that the County does not want the liability associated

with the property. Marie Bing, Esq. noted that there is a prior resolution which has already conveyed the property to the DEP (Res No. 246 of 2016), that the agreement was discussed thoroughly with Mohonk and that Monhonk did approve the deed as is. Marc Rider emphasized that the rights are reserved to Mohonk and since the property has been up for public auction in the past Mohonk has had the opportunity to purchase it and has chosen not to. Legislator Bartels asked when the property was up for public auction and if it has it been analyzed to see if it is of historic significance. Marie Bing, Esq. confirmed that the property has been analyzed. Legislator Bartels asked to see the letter confirming this. Marie Bing, Esq. agreed to follow up with the Committee to distribute the information being requested for review prior to the next meeting.
