Discussion:	Legislator Cahill noted that changes have been made over the last few days and wanted to ensure the current version is explained.
	Legislator Uchitelle, sponsor of the Resolution, explained that the composition of the committee has been changed, language was updated to highlight the requirements, and language clarifying future funding sources have been addressed.
	Legislative Chair Bartels noted that up to \$3 Million is to be made available in the next four months and expressed concern with the short timeline.
	Legislator Uchitelle stressed that it will be a lengthy process to actually spend the funds, however the public notice of funding availability is important.
	Discussion ensued on the timeline of noticing funds, and Legislator Cahill clarified with Legislator Uchitelle that the anticipation is for the oversight committee to be in place within the first month.
	Legislator Cahill expressed concern that no permanent funding stream is in place.
	Planning Director Doyle stressed the importance of having a dollar value associated with the available funds.

	Legislator Roberts expressed concern providing developers with county funds and suggested adding a maximum allowable amount to the fund.

	Legislative Chair Bartels echoed the concerns of Chairman Gavaris and stressed that the county is responsible for these funds but is acting in faith based upon the letters of intent that were submitted. Legislative Chair Bartels also noted the success of iPark in similar locations.
	Legislator Cahill informed the committee that there is activity on the site, money has been invested, improvements have been made, there is an active business operating on the site and others are awaiting site plan approvals from the Town of Ulster, in addition to potential housing projects awaiting approvals.
	Legislator Maloney explained that the county is not allowed to directly enter a ten-year lease and that is why the Ulster County Economic Development Alliance (UCEDA) is involved. Legislator Maloney questioned the status of the space study. Deputy County Executive LaValle explained that a draft is currently with the Department of Public Works.

Comptroller Gallagher stated that the Comptroller's Office has launched an audit of the self-insurance program. The Solar PILOT audit is out to management for comment, Real Property Testing is in process, and the CARES II Audit was released. Comptroller Gallagher explained that sales tax is now up 1.64% over last year and the Q4 2022 report cannot be completed because the 2022 county financials are not yet complete. Additionally, investment revenues are up and an additional \$3.3 Million has been accrued, however better investment opportunities are available, and diversification should be reviewed.

Legislator Criswell informed the committee that ARPA has expanded rules for spending, including two new categories, and will provide a more thorough update at future meeting.
