Deputy County Executive Marc Rider explained that the 680 units covered within the contract are vehicles and that the contract is for software which tracks each vehicle's parts, repairs, and maintenance services, thus providing the fleet manager with the ability to determine whether a specific vehicle is at the end of its useful life or is costing the County more money than its worth. Legislator Bartels questioned why the price of the software is based on a quantity of units.

with everyone contacted for payment of Hotel and Motel Room Occupancy Tax, explaining that there are a number of issues pertaining to the reason the taxes are past due for each individual. Legislator Bartels voiced concern that the County hasn't done enough outreach to inform individuals of the filing and compliance requirements pertaining to the tax. Deputy County Executive Ken Crannell explained that the County has contracted with a firm who specializes in identifying individuals who advertise short-term rental properties within Ulster County, and that many individuals are already registered to pay the tax. Further, Ken Crannell explained that Woodstock is pursuing an ordinance on the matter and that this agreement will allow Ulster County to provide a list of all known individual names and addresses with short-term

rentals, which the Town will use for the purpose of code enforcement and regulation of the ordinance, in exchange for the Town including a requirement within the ordinance that all owners register with the Commissioner of Finance to pay their Hotel and Motel Room Occupancy Tax. Legislator Rodriguez expressed concern that paying the tax is a cumbersome process for many individuals. Ken Crannell emphasized that the County is required to equally enforce taxes and that the current process was the only way to implement a county-wide system which equally enforces the tax while creating a benefit to the towns that choose to participate. Legislator Archer asked for all mass mailings to be sent to the Legislative body so that Legislators may respond accordingly if and when calls are received regarding the mailing. Lastly, Ken Crannell stated that the County is working to implement an online portal for the payment of the tax.

Commissioner of Finance response to Finance and Budget Department staffing levels

Discussion:

Burt Gulnick, Commissioner of Finance, introduced Lisa Cutten, Director of ACE and provided a brief summary of prior communications to the Committee. Mr. Gulnick explained that the Deputy Director of ACE works with every County Department to enter contractual agreements into the financial software for the purpose of invoice payment. Lisa Cutten explained that she primarily handles project accounting within the financial system, providing the committee with a description of these records and this process. Ms. Cutten informed the Committee that the ACE Department tracks construction work in process and monitors the recording of the fixed assets once they're completed, works to support all users of the system, and answers phone calls daily regarding assistance with various transactions. Mr. Gulnick said the Department also helps track state aid spending to assist with compliance with State reporting requirements. Legislator James Maloney confirmed the County's ability to track FEMA disasters. Mr. Gulnick stated that there are 423 users of the financial system software across the nation and that ACE contains 1 of 15 individuals on the software's advisory board. Discussion pursued on the County's use of the financial software and the payroll module in comparison to the payroll software currently utilized. Legislator Bartels inquired of ACE's responsibility to complete program performance evaluations. Ms. Cutten explained that ACE does not complete a formal report pertaining to evaluations but rather looks at departments and then assists and works with them to create efficiencies in a way that is interactive and collaborative. Discussion pursued on the efficiencies that have been executed within the County since the inception of ACE and the transition to the financial software. Legislator Archer asked if ACE is assisting departments to record transactions and budget transactions in a

manner that is consistent across the County. Mr. Gulnick answered that ACE does assist with this where possible.
