Everett Erichsen, Director of Emergency Services, provided an update on the County Wide Radio system. Director Erichsen stated that while the terrain of Ulster County is beautiful, it causes issues with the radio system. Additionally, fire departments and law enforcement require different needs. Director Erichsen went into detail regarding the location of current towers and where future towers may be added to create a functional system. Director Erichsen noted that this upgraded system is a huge improvement to the current system and a giant step forward for an operable system between fire, law enforcement and EMS. Director Erichsen went on to inform that the committee that to date there is \$7.5 Million in grant funding received with a county share of \$24.3 Million and a total cost of just under \$32 Million.

yes and this time and felt that it was a complicated system.

Legislator Nolan stated that this would be appropriate in the time before

legislative financial analysts.

Legislator Ronk echoed Legislator Roberts and called the question.

Discussion: Legislative Chair Bartels noted that there has been no changes as of yet and

feels there should be a bottom end threshold.

Legislator Erner shared that without a bottom end exclusion, the addition of this tax would have brought \$2 Million into the county on last year's sales. Legislator Erner stated preference to no bottom end exclusion but would be agreeable if that is what it needed to pass this Resolution, noting that the tax rate is very low and only one quarter of what the state is imposing.

Legislator Petit, as cosponsor, stated that there had been discussion on imposing the tax on the purchaser, rather than the seller, and noted that some municipalities put the additional tax towards open space.

Legislator Ronk informed the committee that New York State has some of the highest closing costs of any state in the nation and would not support this Resolution.

Legislator Roberts stated that by not imposing this tax, money is kept in the hands of the Ulster County Residents.

Legislator Cahill noted that residents are struggling to afford housing, due to high interest rates and high housing values and does not support an additional tax.

Chairman Gavaris agreed that no amendment would change his mind and stated lack of the support for the Resolution because the buyer would just be able to pay less for the house to afford the additional tax, therefore still impacting the seller.

Legislator Erner stated that the intent of this tax is to fund housing for those who have none.

until a future tax sale.

Legislator Uchitelle requested a memo be prepared from either the Department

of Finance or the County Attorney's Office to fully explain the issue and plan.

Legislator Ronk agreed with Legislator Uchitelle but suggested a presentation, so legislators have the opportunity to ask questions.

Deputy County Executive LaValle agreed to the request and noted that this uncertainty is across all municipalities and the timeframe to go from foreclosure to auction is a tight timeframe, which is intentional, to limit the length of time where the county is the owner of the properties.

Legislator Maloney suggested going forward with the tax sale and putting all proceeds into an account to await guidance on what to do with the funds. Commissioner Daw agreed to look into this and stated other counties have suggested doing the same.

Legislator Chair Bartels noted that the extinguishing of the liens will become wildly complicated.

Discussion ensued on what to do while the process is in limbo.

Deputy Comptroller DeMarco provided a sales tax update, stating that sales tax is up 3% for the year and when comparing to last year it is important to note that the gas tax holiday was in place.

Deputy Comptroller DeMarco added that the solar audit was released, a real property tax audit will be released soon, and the department is working on an audit on the county's self-insurance fund. The Q2 2023 report will be available shortly but has been awaiting the final financial transactions to be posted for the period. Finally, the Comptroller's Office released a public pay dashboard of the county's employees.

Chairman Gavaris asked if there was any old or new business.

Legislator Maloney questioned the status of the Space Study and Deputy County Executive LaValle explained that the space study is in a pre-draft form which consists of only preliminary sections of the report filled in and other sections are completely blank. Dissatisfaction was expressed by the lack of timely deliverables from the company.

Legislator Maloney questioned the potential Department of Social Services write off. Legislative Chair Bartels expressed frustration with the previous external auditors and noted that the current auditors flagged the potential issue and explained that a definitive number is not yet available. Legislator Maloney suggested requesting the work papers of the previous auditors and Legislative Chair Bartels confirmed that step has already been taken. Legislative Chair Bartels explained that the county is also waiting on the audit of the Ulster County Soil & Water component unit to be completed. Legislator Maloney questioned the reconciliation process and who the last person to successfully complete the tie out was. Commissioner Daw expressed reservations that an official reconciliation was ever consistently completed. Legislator Maloney confirmed with Director Juras that in a former county career he completed this reconciliation. Director Juras noted that this function is typically a Department of Social Services responsibility and it had only fallen to then Deputy Budget Director Juras because of his previous experience.

Legislative Chair Bartels detailed some issues regarding the former independent auditors.
