Ed Jordan, Director of the Purchasing Department, provided a brief update with year-to-date statistics on procurement, mail, consulting and vending machine revenues. Director Jordan stated that the department is responsible for an estimated \$300,000 of cost savings / avoidance. Discussion ensued on the county's vending machines. Director Jordan reminded the committee that there has been significant turnover within this department in recent years and reviewed the 2024 County Executive Recommended Budget.

Legislative Chair Bartels confirmed that nonunion longevity is not in individual lines and requested that each position line show the entire pay compensation in the future.

Comptroller Gallagher introduced Alaina Voulgaropoulus, the Quality Analyst within the Comptroller's Department. Ms. Voulgaropoulus explained that incoming invoices are now being tracked, to see if they are related to a contract, and the Comptroller's Office is reaching out to departments for contractually obligated reports. Ms. Voulgaropoulus explained that the vision is to create a vendor dashboard which will show all contracts, payments, data points, etc. Ms. Voulgaropoulus was met with enthusiasm from members of the Ways & Means Committee regarding the draft version and vision of the vendor dashboard.

Comptroller Gallagher informed the committee that a vehicle is being reimbursed through a contract with SAMADHI and provided a second example of this occurring but highlighted the differences between the two contracts and subsequent vehicle purchase. Comptroller Gallagher suggested the legislature adopt a policy for vehicle reimbursement under county contracts.

Discussion ensued on the potential for a policy, the differences between the two vehicle purchases, and the need for these vehicles.

Resolution No. 432: A Policy Requiring Venders To Comply With All Applicable Ulster County Policies
