Motion No. 2: To approve Resolution No. 298 – Authorizing The Chair Of The Ulster County Legislature To Execute An Extension Of The Sales Tax Agreement With The City Of Kingston

**Resolution Summary:** This Resolution approves the agreement between the County of Ulster and the City of Kingston providing for the distribution and allocation of sales tax to the municipalities for a term of five years, commencing March 1, 2021 and ending February 28, 2026.

**Discussion:** Legislator Cahill informed the Committee that he discussed this

agreement with the Mayor of Kingston and the County Executive and he believes there should be some consideration given to the allocation of sales tax revenue as it relates to the Town or Village's relative proportion of sales tax earned. Legislator Walter agreed with Legislator Cahill's points, stating she will not support the agreement. Chairman Donaldson said the City of Kingston isn't supported by the County proportionately compared to the Towns and Villages, providing a brief history of past discussions relating to the agreement. Legislator Bartels agreed with Legislator Walter's approach in asking for a one-year agreement to allow time for deeper discussions and negotiations, stating that she is disappointed this wasn't able to move forward when it was

proposed.

**Discussion:** Legislator Bartels stated she does not support the use of the tax

stabilization fund at this time, that she would like to see the 2021 budget, and that after seeing the budget is a more appropriate time

for this discussion. Chairman Donaldson agreed with Legislator Bartels, saying he would like to see this postponed until better numbers are available. Legislator Ronk noted that the use of the account is subject to a permissive referendum which would then consequently be postponed. Burt Gulnick, Commissioner of Finance stated the reserve can only be used for "unknown expenses" and therefore may not be appropriated via the budget, and that the funds will impact fund balance. Discussion pursued on the incidences in which the tax stabilization fund may be utilized.

Legislator Ronk stated, upon considering the timeline of the permissive referendum, he cannot support the Resolution's postponement. Legislator Bartels questioned if there are any other accounts with funding available for use such as Contingency. Commissioner of Finance Gulnick stated that each account is approved by the Legislature for an intended use and therefore no other funding is available. Comptroller Gallagher informed Committee members that she has reached out to the New York State Office of the Comptroller to question legislation passed on the State level to allow for the use of this fund which requires repayment within 5 years, and also to question if fund balance or contingency are available, whether these funds should be used first. Further, Comptroller Gallagher pointed out that it may currently feel like this is the worst the pandemic is going to get, but it may very well not be. Commissioner of Finance Gulnick argued that he needs to be able to estimate what fund balance will be for the creation of the 2021 budget and that he cannot do so if this Resolution is held up. Legislator Gavaris questioned if FEMA and other reimbursement funds have been taken into consideration in covering these unforeseen expenses. Commissioner of Finance Gulnick answered no because FEMA reimbursement may take years to receive. Legislator Bartels questioned whether budgeted overtime has been accounted for. Commissioner of Finance

Gulnick agreed to follow up with Committee members after

discussing with legal counsel.

Chairwoman Archer: special meeting? Okay, and the 18th. And no one had any changes? Okay, all in

Okay, let's get right into resolutions.

Resolution 298: Authorizing The Chair Of The Ulster County Legislature To Execute An Extension Of

The Sales Tax Agreement With The City Of Kingston.

**Legislator Ronk:** I'll move it.

Legislator Bartels: I'll second.

Chairwoman Archer: Second?

Legislator Bartels: Second Bartels.

**Chairwoman Archer:** Okay. Any discussion? Any questions? All in favor?

**Group:** Aye.

**Chairwoman Archer:** Opposed?

Legislator Cahill: Hey, hey Lynn? Lynn, this is Brian Cahill. Do you mind if I just chime in for one

second here? I'm sorry.

**Legislator Haynes:** No, go ahead, Brian.

**Legislator Cahill:** Okay. So, I, I just want to say that, you know, I, I've discussed this with, like I said

before, with the Mayor of Kingston, with the Executive, personally, and members of his staff. And I just

think that, you know, there should be some consideration to some of, some of the other towns as to the proportion of their distribution being a little bit more equal to their contribution overall to the sales tax revenue, to the county. And this is something that goes on, every time there's a sales tax agreement. It's always the next one, well, we'll take a look at something down the road. Or we'll do something after the sales tax agreement, or this, or that, or another thing. And nothing ever becomes of it, right?

And so I'm just going to tell you guys that when this comes to our caucus, and when it comes to the floor, I'm voting against it. And I'm speaking out against it because I, I reached out to several members of, of the Executive staff and administration with suggestions on how we could work, a shared service agreement between specifically Town of Ulster, City of Kingston, and the County to try and help us relieve some of, you know, our tax burden for the taxpayers of the Town of Ulster. Considering how much of the sales tax goes from the Town of Ulster into the county coffers, right?

We, we've discovered during COVID that car sales are a big, a big, big contributor, right? And where all the car dealerships? They're all in the Town of Ulster, right? Where all the major grocery stores and department stores, they're in the Town of Ulster, right? What's left them anyway, right? So, I just think that at some point here, we have to stand up and say, you know, let's be a little bit more fair about this than we're being. So, I just want to get that off my chest because it's something that I see repeating basically my entire adult life. And it seems a little bit unfair.

Chairwoman Archer: I appreciate your comments.

Legislator Walter.

Legislator Walter: So, I, I agree wholeheartedly with the intent of everything that Legislator, Legislator Cahill said, I had made an attempt to have us pass a resolution that would only allow for one year, for this particular agreement, so that we had the time and capacity to explore all of the different kinds of options that are available and are utilized in counties all around us. Again, this is never an intent to reduce the amount that the City of Kingston was getting, but potentially provide more to the towns, as Legislator Cahill said proportionate to their input. New Paltz is also one of those places. And so, I was unable to get that resolution to even be discussed, because I could not get the support for it. But I will have to say that I will not support this resolution for the same reasons.

**Chairwoman Archer:** Okay. Any other comments? Chairman Donaldson?

**Legislative Chairman Donaldson:** Yes. The, as everybody understands, the City of Kingston is the only place in the Ulster County that can also have its own sales tax. And that's what the agreement is all about.

Also, the idea is, as everybody understands, the City of Kingston has no bridges, no roads or any of that type of things being done by the county. Also a significant amount of county services are on, you know, are in the City of Kingston and being taken off the tax roll.

But actually the reason the whole sales agreement came about was because the City of Kingston had its own taxes and they decided that the best way to do this would let the county tax, and then the City of Kingston gets a, a chunk of that numbers.

I think it was 2000. I'm not sure if it was the year 2000. I don't remember what it was. I know. T.R. Gallo was the mayor in the City of Kingston. Up until that point, the counties got absolutely nothing. Zero. Nada. That actually T.R. Gallo negotiated for the towns, and the City at that time, with Dan Alfonso to increase the numbers and give the town the percentages that they have now.

Technically, there is nothing in the law that says that the town can get anything. I think they should. And I think that should be negotiated. And I think the city attempted to negotiate that in the past for more money for the towns, but it's not been successful.

But, you know, only time it was a really successful was with T.R. Gallo when he did that, and that's, you know, that's the history of all that. I will be supporting it. And that's about it.

Chairwoman Archer: Legislator Bartels.

**Legislator Bartels:** Thank you. Yeah, I, I have mixed feelings. I'm probably going to support it to put it to the floor, but I'm not sure that I'm going to support it on the floor.

I agreed with Legislator Walter's approach. I think that given the uncertainties of COVID and sales tax revenues, the impacts of the sales tax revenues, that we, especially in that phase, were uncertain what we were going to be seeing.

This isn't a, this isn't a year where we could really easily make radical changes. But I think we need to have the conversation that Legislator Cahill was talking about. And the only way to do that would have been to maintain the agreement as it is for another year and put off the deeper negotiations. So, I regret that that was unable to move forward when it was proposed.

**Chairwoman Archer:** Okay, any other comments, questions, concerns? On the resolution? All in favor?

**Group:** Aye.

Chairwoman Archer: Opposed?

Do we have any? Okay, just Walter.

Okay. Great. Thank you.

Resolution 299: Authorizing The Use Of The Tax Stabilization Reserve Fund For COVID-19 Related Expenses. I'll take a motion.

**Legislator Ronk:** So moved.

Legislative Chairman Donaldson: Move it. I'll second.

**Chairwoman Archer:** Second? Okay.

Legislator Bartels.

**Legislator Bartels:** I do not support the use of this at this time, I would, I'd like to at best postpone. That we propose that we postpone it. I would like to see the budget, once the budget's proposed, which is, we're less than a month out from seeing that. You know, I think that would be a more appropriate time to have this discussion. But I'm not making the proposal yet. I want to hear what everybody else has to say in terms of.

**Chairwoman Archer:** Okay, any other comments?

**Legislative Chairman Donaldson:** I mean, I

Chairwoman Archer: Chairman Donaldson.

**Legislative Chairman Donaldson:** I tend to agree with Legislator Bartels. I mean, I think that I'd like to, you know, see this possibly postponed until we see better numbers. I'm leery of using it at this point. Although I understand that this was part of the process of, you know, why we have such a fund. But on the other hand, you know, I would probably like to see better numbers before actually pulling the trigger on this.

**Chairwoman Archer:** Okay, anybody else want to make comment? Legislator Ronk.

**Legislator Ronk:** Thank you. You know, I've gone, you know, back and forth on this. You know, I'm not wild about the idea of using it outside of the budget process. I don't know that I would necessarily oppose a motion to postpone. The only concern I have about that is that I believe that I've heard it's the opinion of at least one counsel that this would be subject to a permissive referendum. So, if we were to postpone this a month, it would then postpone the permissive referendum schedule, by a month. You know, I, I've come closer to being able to support using it outside of the budget only because of the reasons that we can use this at all which is for unanticipated expenses which you wouldn't necessarily be incurring during the budget.

The Commissioner of Finance is here if anybody has questions for him, I, I took the liberty of speaking to him myself. And he was kind enough to send the, you know, guidance from the State Comptroller's Office on the use of tax stabilization reserve funds.

So, I, you know, I'm willing to support moving into the floor. You know, if a motion to postpone is made, we can have that discussion, but I am concerned about moving back the timeline on the permissive referendum.

Chairwoman Archer: Chairman Donaldson.

**Legislative Chairman Donaldson:** Yeah, could we get Burt to weigh in for us?

**Commissioner Gulnick:** Sure, just like Legislator Ronk says, I think you all are aware of this reserve can only be used for unknown expenses. So with that, it's not something we can appropriate via the budget. But also, this will impact our fund balance.

I estimate, you know, roughly there's \$1.7 million in this resolution, it's going to come from fund balance. This wasn't planned. There's no revenue to offset this. And that's why this resolution is, is before you now. It only can be used for cases where, you know, a pandemic, pension, unexpected pension costs during the year, or things like that. So, I think you're all aware of that. And that's why this kind of resolution is in front of you tonight.

**Chairwoman Archer:** Legislator Bartels.

**Chairwoman Bartels:** Just a question, the Commissioner Finance is saying it can only be used for unanticipated expenses in a pandemic or otherwise. Can it be used to offset a projected increase in the amount of real property tax?

**Commissioner Gulnick:** Legislator, Legislator Bartels, it can if you exceed the 2% in real property tax.

**Legislator Bartels:** Okay. And there's nothing that says the timing in terms of the unanticipated expenses, we still have the unanticipated expenses that we're talking about offsetting a month from now. So, it doesn't say we have to do it this month. We could do it next month. We just face the timeline for the permissive referendum.

**Commissioner Gulnick:** It was presented, it was presented this month because as Legislator Ronk had mentioned the 45-day referendum. And to be honest with you, I'll let the attorneys figure that piece out. But that's why it was presented in September. So, that way it could affect the 2020 calendar fiscal year.

**Legislator Archer:** And in my calculations, I, I thought even if we postpone it a month, we still could pass it in December, at the same time, we're looking at the budget. And I think this is part of just having a holistic view of all the moving parts, including where we're headed next year to have a good understanding of how we're using this money. So, according to my calculation, that 45-days would take us to the first week of December. And we still have the month of December for finalizing budget, finalizing the use of this, etc., if that word how we wanted to proceed.

Legislator Bartels.

**Legislator Bartels:** Well, I was going to make a motion to postpone since we can only postpone to the next meeting. I was going to make a motion to postpone to the next meeting with the intention of postponing it till the following month.

Legislator Gavaris: I'll second it.

**Chairwoman Archer:** Okay, on the postponement. All in favor?

Legislator Bartels: Legislator Ronk has his hand up.

**Chairwoman Archer:** Oh, sorry, I didn't see it. You're in the shadow there, Ken.

**Legislator Ronk:** Am I?

Chairwoman Archer: Your hand was. I'm sorry I didn't see.

**Legislator Ronk:** It's all good.

Chairwoman Archer: The other one is in the light.

**Legislator Ronk:** I'll do my best.

**Chairwoman Archer:** There you go.

**Legislator Ronk:** So, I, you know, after hearing, actually, Legislator Archer, this is kind of humorous. After hearing, you know, your timeline on it, which would put, you know, the, you know, timeline on a permissive referendum into, you know, into the first week in December, which is really when we usually adopt our budget, how are we going to move through our budget process?

**Chairwoman Archer:** No, it's within the 45 days. So, the 45th day would be the first week of December, at the end of that. So, that gives us.

**Legislator Ronk:** I, I understand but we wouldn't be able to, we wouldn't be able to count on the use the stabilization fund in year 2020 unless the 45 days had elapsed. Because otherwise, somebody could come in, on the 45th day, with the signatures for a permissive referendum. And we would no longer be able to use that until after said permissive referendum, which is a significant amount of time after that, as well. You know, I don't know that I can support the postponement. You know, I know, it's just until next week, technically, because it's until the next meeting, but, you know, it seems like the goal is to have it postponed until next month.

You know, I just feel like it's going to put us in a bind as we move through our budget process, not knowing if this \$1.7 million is going to be available or not. And if, you know if the end if the end result is, you know, we're all a month older in October, and, you know, we're going to pass it then. I just don't see, unless there's a significant policy argument against doing it now, which I've not heard today, you know, contrary to what the Commissioner of Finance has said to us, I don't see the utility in waiting.

**Chairwoman Archer:** Legislator Bartels.

**Legislator Bartels:** Just speaking for myself, I don't hope to be just a month older, I hope to be a month wiser in terms of actually having the budget in front of me to look at and to see what it is we're facing. Can I ask a question of the Commissioner of Finance?

**Chairwoman Archer** 16:25

Please, yes.

**Legislator Bartels:** In terms of the guidance from the from the Comptroller, it's said that monies in the fund can only be used to finance that portion of the expenditure, which cannot be financed from monies available in any other account or fund. Is there no other account in, in our, that we can use to fund any of this?

**Commissioner Gulnick:** Yeah. In terms of, in terms of that. I mean, the budget was adopted by the Legislature with a plan in place. With that, too, there's no other funds that I can grab from. Because the other funds have specific designations as to what you can use them for.

**Legislator Bartels:** But that includes contingency?

**Commissioner Gulnick:** Well, in terms of what you have in your budgeted contingency, there's roughly \$400,000 in there. I will say, it may be something in December. I come back and tap the \$400,000 because I know that \$1.7 is only as of July 31.

**Legislator Bartels:** But, But Burt, right now, right now you're trying to tap this money. And the guidance says that it can only be tapped, using your language, that it can only be tapped if there's no other fund that it can be tapped from, by law. So, is there no other fund, that by law, we can?

Commissioner Gulnick: Not by fund. No, because each of the funds have a designation as to their use.

**Legislator Bartels:** It says account or fund.

**Commissioner Gulnick:** Yeah. And the accounts have been passed by the legislature.

**Legislator Bartels:** Contingency account. What's the specific use designated for a contingency account?

**Commissioner Gulnick:** That's up to the Legislature.

**Legislator Bartels:** But so, it would, it would seem to me that a contingency account, by law, could be used to offset unanticipated expenses. That's what contingency accounts are for.

**Commissioner Gulnick:** Of the of the \$400, Yes, the \$400,000 you have in there, I'm not disagreeing with you. Again, I could amend that resolution to have \$400,000 out of contingency.

**Legislator Bartels:** I'm just asking if you have to because it says that as a matter of law.

**Commissioner Gulnick:** I can ask legal, I can ask legal that. Yep.

Chairwoman Archer: Comptroller Gallagher.

**Comptroller Gallagher:** I really don't want to take the conversation off track here. But I want everybody here to know that I have a question out to OSC exactly on this point. I agree with the Executive. If not now, when? Right?

But I want to point out two things. One is that there was legislation at the state level to allow using these funds, because the covid legislation would require us to have a plan to repay the fund within five years.

And then, so, I just have a request out like, okay, we're not going the emergency route. So, other municipalities who've tap their Tax Stabilization Fund, what criteria have they used, i.e., you know, is fund balance available? Is contingency available, etc.? And do we need to use those first?

And then I just want to say one last thing that's kind of come to me in the last couple of hours, which is, you know, this feels like the worst it's going to get. But that may not be true. And five years from now, when we're in the fifth year of the COVID depression, we might feel differently. So, it's just, I've just sort of come to that conclusion myself over the last, you know, few hours.

But I think we do need to think about things could get worse. On ways to avoid tax increases, and we don't know if we're going to need one right now. I'm hoping to have an answer back soon. Um, and I will report back to you guys as soon as I know something, but I do have this question out to the Office of State Comptroller. Thank you.

Chairwoman Archer: Legislator Maio.

**Legislator Maio:** Thanks. I have a question if I'm really on the fence here. I know we voted but I might want to change my vote. If we were to say yes to this, because I'm afraid, like Legislator Ronk, to postpone for a month because of the timeline. Any funds that came out of this, how would we know? What, what, how do we follow a dollar limit on this for anybody who wants to take any funds from here? Does everything come before us?

Burt Gulnick: In terms of the use of this fund? It has to have Legislative approval. Correct.

**Legislator Maio:** Okay, well then I'm going to, I want to change my vote then. Lynn, I don't know if you want to do another vote or not, because I don't want to cut off our nose to spite our face.

**Chairwoman Archer:** Before we do, I'm sorry.

**Legislator Maio:** I don't want to cut our noses to spite our face. I think if this is available, we should make it available to us, it doesn't mean we have to use it.

**Burt Gulnick:** Can I just say something on the timing of this, too? Legislator Ronk mentioned the budget process. Keep in mind with the Exec budget, I have to estimate what the fund balance would be, which is not a separate fund. It's just the, the bottom line of the county. With this being held up a month, it basically will impact our fund balance because there's no other place to take these funds from. So, I just wanted to make you aware of that.

Chairwoman Archer: Okay, Legislator Haynes.

**Legislator Haynes:** Yeah, for my understanding it was, this was for unseen, unforeseen emergencies. So, if we're moving into next year, and we all know that the COVID is, it's not unforeseen anymore. It's, so how do we, are you saying that there's going to be like a co-occurring disaster that was unforeseen next year, rather than the unforeseen one for this year. I'm a little bit confused with postponing it. In regard to that. We already know COVID was an unforeseen emergency. But as of January next year, it's not going to be unforeseen. And how would, we wouldn't be able to utilize it? Can anyone speak to that?

**Commissioner Gulnick:** My understanding is if we know about it, in terms of cuts, or things like that, we cannot use this fund.

**Chairwoman Archer:** Legislator Bartels.

**Legislator Bartels:** I mean, I think at the least, we need to postpone it the week, because we have outstanding questions both that the Comptroller has acknowledged asking the State Comptroller, and that that our Finance Director has said that we need to ask legal, because, so, I think at the least we need this week.

Chairwoman Archer: And one thing that I would, go ahead, Legislator Gavaris, sorry.

**Legislator Gavaris:** Can I just clarify what thing Burt said before in relation to what Marybeth had asked? You said it needs legislative approval, you mean to move this money or for each individual expense that you will use the money for?

**Commissioner Gulnick:** To use this fund but as backup to this, I did provide what would be transferred.

**Legislator Gavaris:** Okay, because I think that's what Marybeth was asking. I think she was concerned with how the money would be spent. So, once we give it to you, essentially, it's out of our hands, the money can be used in any fashion you want to, once you have it.

**Commissioner Gulnick:** That's kind of why I waited till now. So that way the departments wouldn't go ahead and spend this money. I just need to basically reimburse them for their expenses that were unplanned and unbudgeted for.

**Legislator Gavaris:** And what about FEMA money and all the other programs that have been out there to give, you know, money back for things that we've spent, has that all been accounted for, and we're sure we're not getting any more of it?

**Commissioner Gulnick:** The transfers that I've put forth are just for FEMA reimbursement, expenses or eligible expenses. Keep in mind, we're not going to get reimbursed for FEMA, I don't expect for a couple of years. I will say they we, actually, just this past August, we got reimbursed for tropical storm Lee, which was back in 2011. So, and that was FEMA. So, that took seven or eight years. And we think we got the last reimbursement from that. So, this isn't going to be a quick reimbursement from FEMA.

**Chairwoman Archer:** Legislator Bartels.

**Legislator Bartels:** One other technical question, again for Commissioner Finance. In terms of determining the amount that was eligible to use, and coming up with this number, did you minus the budgeted amount? For example, if, if you're looking at overtime lines, did you minus the amount budgeted for overtime? Or did you make the assumption that it wasn't budgeted for COVID overtime, and therefore, all COVID overtime was unanticipated.

**Commissioner Gulnick:** This is just COVID overtime that we're going to claim towards FEMA. That's all that is included here. It didn't have any. I did not look at the budget for overtime.

**Legislator Bartels:** But doesn't the guidance say that you have to minus, I mean, the guidance on unanticipated expenses? And the examples that I used, I saw used overtime. And it, it showed misusing the amount of budgeted overtime against the unanticipated expense of additional overtime. And so, that's another, that's another question I have. Is if we're applying all of the overtime related to COVID, we would have to minus the amount of budgeted overtime, in terms of what's allowed to be applied to this fund. Which is probably another question for legal.

Commissioner Gulnick: Yeah, I'll follow up. I'll reach out and see if I can get an answer.

**Chairwoman Archer:** Okay, so we do, Chairman Donaldson.

**Legislative Chairman Donaldson:** Did we actually vote on the postponement?

**Chairwoman Archer:** We stopped, we haven't. We have a postponement motion on the table. We have not voted on it.

**Legislative Chairman Donaldson:** I mean, I, I can support to postponement until next week, but you know, just to get a couple of these answers. But I'm not sure if I will support it for, you know, or for the following month.

**Chairwoman Archer:** Okay, so on the postponement until next week, all in favor?

**Legislative Chairman Donaldson:** I'll be good for that.

Chairwoman Archer: Okay, and opposed?

**Legislator Ronk:** Opposed, Ronk.

Chairwoman Archer: Ronk and Haynes. Okay, thank you everyone.

I mean, I, I imagine it'll be all okay. But it does raised some concerns because it's \$450,000. And just having that documentation of where that increase came from was, again, discussed in both meetings.

And, frankly the way the systems are working between our police departments, every one of these cars has to have two police radios for two different types of bandwidth. One's a digital radio and one's a VHF-type radio. So, this is simply to continue a contract that they've had for police radios in DA's investigators cars. Not URGENT. So.

**Legislator Archer:** Legislator Ronk did I see your hand up?

**Legislator Ronk:** Yeah. I mean, I'll leave it alone unless anybody has any further questions on the radio stuff because I actually have some knowledge here. But if no one has any further questions further than that, I'll leave well enough alone

**Legislator Bartels:** Do you want to just share your knowledge?

**Legislator Ronk:** I mean, you know, just in, in different areas of the county, you know, different agencies use either VHF or UHF frequencies. And, you know, in order to be able to communicate with all of the emergency services units around the county, you need to have both in all vehicles. You know, most of our fire departments, ambulance corps, police departments have both VHF and UHF radio in their cars and in their emergency vehicles. So, if you're going, if you're going to put radios in the DA investigators cars and dispatch them to emergencies, they'll need to have both. I think that that's one major reason why the radio upgrade is so important because once that happens, everyone should be working off the same equipment.
