**Discussion**: Legislative Chair Bartels explained that after extensive discussion with the

County Executive's Office, the budget has been updated to include all current tenants, while cleaning, fuel, snow removal, maintenance and other repairs, garbage removal, were all adjusted downward. Legislative Chair Bartels went

on to explain that these cuts were made by the new property manager from the old property manager's original budget.

Legislator Ronk expressed concern that the property is now publicly owned, and some level of due diligence is needed.

Legislator Nolan stated that the numbers are estimates and the Executive Offices' best guess.

Legislator Maloney questioned who will oversee the procurement process for Vetere Real Estate LTD, as the company must follow county procurement guidelines. Deputy County Executive LaValle explained that the property manager will work with the Ulster County Department of Public Works to follow the proper procurement process.

Legislator Cahill noted the size of the building and questioned if the maintenance firm has worked with similarly sized buildings. Dean Rylewicz, Deputy Commissioner of DPW, explained that Vetere previously managed 368 Broadway, and two properties affiliated with Kingston Hospital, all of substantial size.

Legislative Chair Bartels stated that the contract is in draft form and that the Legislative attorneys are going to review the contract with the County Attorney as the contract intends for a joint bank account and the county was going to reimburse the firm for half a million dollars of tax payments.

Chairman Gavaris stated that he toured the building, and noted the extreme size of the building.

Legislative Chair Bartels redirected the conversation and asked if any additional specifics need to be added to the Resolution for the Public Hearing.

Legislator Ronk stated that no damage will be done by moving forward, however, further delaying this Resolution could be detrimental.

Comptroller Gallagher stated that in light of recent events the Comptroller's Office has a series of requested changes for the Charter Revision Committee, however, it does not appear that suggestions will go to ballot this year and therefore Legislative approval will be needed. In addition, a Real Property Audit and 2022 Sales Tax Update have been issued and the office is currently auditing IDA (Industrial Development Agency) and Solar Pilot Agreements, also reviewing CARES I, various capital projects, and working with UCEDA on the iPark transactions.

Legislator Maloney noted that the Legislature added the Quality Analyst to the Comptrollers Department and questioned if Legislators would be allowed any input into the various tasks or reviews that are assigned. Comptroller Gallagher was agreeable and explained that the plan was to create different groupings of contracts to aid in the direction of the analysis.

Chairman Gavaris moved on to the Forthcoming Local Laws portion of the agenda.
