Chair Gavaris and Chair Petit called the meeting to order at 3:07 PM.

Chair Gavaris gave the floor to Scott Bova of Bergmann for an overview of the Space Study. Legislator Criswell inquired if access to County properties from public transportation was factored into their need assessment at all. Mr. Bova said it did not. Chair Bartels stated she was disappointed not all departments did not respond to the Space Study survey. Chair Gavaris stated that total square footage of space would be valuable. Legislator Cahill asked what was overutilized and underutilized. Mr. Bova answered that the Office of the District Attorney was in the most critical need of both more space and consolidation and that the Department of Tourism was the most underutilized space.

The Committee discussed the details of the 2024-2029 County Executive Recommended Capital Improvement Program including:

- DPW Central Auto
  - o The number of vehicles that will be all electric in the next five years.
  - o Potential updates to the take home vehicle policy.
  - o Tracking mileage.
- Mental Health 368 Broadway Geothermal
  - The cost effectiveness of drilling wells to site the geothermal heating source and potential grant funding to cover said cost.
- Health Crisis Stabilization Center
  - o Estimated timeline of completion, which was stated to be June 2024.
- Public Safety License Plate Readers
  - o Concerns of privacy, ownership of data collected and the length of time data is kept.
- Transportation Bus Shelters
  - O The delay in the construction of these shelters which were meant to be started in 2023. Deputy County Executives stated that delay was caused by maintenance of effort agreements from municipalities.
