WHEREAS, the New York State Board of Elections has allocated certain funds in the amount of \$8,432.00, to Ulster County to improve access to polling places for individuals with disabilities, and

WHEREAS, the Commissioners of the Ulster County Board of Elections have requested that the Chairman of the Ulster County Legislature be authorized to execute a contract (Contract No. C1100260), and any amendments thereto, for the period April 1, 2011 through September 20, 2015, in the amount of \$8,432.00, with the New York State Board of Elections to receive the allocated funds for the HHS 2010 Voting Access for Individuals with Disabilities Polling Place Access Improvement grant, and

WHEREAS, the purpose of the allocated funds is to establish, expand and improve access to polling places and participation by individuals with a full range of disabilities in the election process, and

WHEREAS, the New York State Board of Elections Contract will be administered over a four (4) year period, beginning April 1, 2011 through September 30, 2011, and

WHEREAS, the Governmental Services, Environmental and Administrative Committee has met and reviewed said request with a majority of the members voting approval, and
