The Governmental Services and Administration Committee (Chairman Roberts and Legislators Belfiglio, Fabiano, Ronk, Madsen, Parete and Rodriguez) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of the Environment, and

WHEREAS, pursuant to Resolution No. 424 dated December 12, 2007, the Ulster County Legislature adopted the Ulster County Open Space Plan in recognition of the importance of preserving open spaces, protecting wildlife, and creating recreational opportunities, and

WHEREAS, pursuant to Resolution No. 182 dated June 11, 2008, the Ulster County Legislature authorized the Chairman of the Ulster County Legislature to apply to the New York State Department of Environmental Conservation Hudson River Estuary Program for a grant not to exceed \$30,000.00, and

WHEREAS, the grant will allow the further implementation of Ulster County's Open Space Plan by updating the County's Natural Resource Inventory Database and making it available for use by the public through a web-based map interface, identifying Priority Conservation Areas within the County, and funding the creation of water resource mapping, and

WHEREAS, the Hudson River Estuary Program grant requires municipalities to match state funds, and

WHEREAS, Ulster County is in receipt of a Notice of Grant Award Contract (Contract #T303984) for the period October 28, 2008 through September 19, 2013, in the amount of \$30,000.00 from the New York State Department of Environmental Conservation, with a required match by Ulster County in the amount of \$10,000.00, and

WHEREAS, as a condition of the grant, the Contract must be executed and submitted prior to May 15, 2011, and

WHEREAS, the Governmental Services and Administration Committee has met and reviewed said request with a majority of members voting approval, and
