

**Authorizing The Chairman Of The Ulster County Legislature To Enter Into Certain Inter-Municipal Agreements For The Community Work Experience Program – Department Of Social Services**

The Health and Human Services Committee (Chairman Frey and Legislators Harris, Petit, Ronk, Briggs, Robert Parete, and Stoeckeler) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Social Services, and

WHEREAS, New York's General Municipal Law Article 5-G and Section A3-4 (Y) of the Ulster County Administrative Code provide that the Chairman of the Ulster County Legislature can enter into an inter-municipal agreement on behalf of the County of Ulster, and

WHEREAS, the Commissioner of the Ulster County Department of Social Services requests that the Chairman of the Ulster County Legislature be authorized to execute the inter-municipal agreements for the Community Work Experience Program with the following municipalities:

City of Kingston, Town of Denning, Town of Gardiner, Town of Hurley, Town of Olive, Town of Plattekill, Town of Rochester, Town of Rosendale, Town of Shandaken, Town of Shawangunk, and Town of Ulster, and

WHEREAS, the Community Work Experience Program provides municipalities and public/private not-for-profit agencies with workers who are unable to find jobs and who need to work to receive benefits under the Temporary Assistance to Needy Families, Safety Net Assistance Project, and/or Food Stamps Program, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute the inter-municipal agreements with the above-referenced municipalities in relation to the Community Work Experience Program, as well as amendments to these agreements, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and, be it further

RESOLVED, that the Chairman of the Ulster County Legislature is authorized to execute additional inter-municipal agreements for the Community Work Experience Program with other municipalities as necessary,
