WHEREAS, pursuant to General Municipal Law Section 119-n(a), the definition of a municipal corporation includes a school district, and

WHEREAS, Ulster County desires to support an educational event aimed at reducing drunk and drugged driving in connection with the New Paltz High School senior prom, and

WHEREAS, the Coordinator of Ulster County STOP DWI requests that the Chairman of the Ulster County Legislature execute an Inter-Municipal Agreement, and any amendments thereto, with the New Paltz Central School District for a Victim's Impact Panel presentation to be held at New Paltz High School on March 23, 2010, and

WHEREAS, Ulster County STOP DWI will pay \$10.00 toward the prom ticket of each New Paltz student who attends the presentation accompanied by a parent or guardian, with the amount paid to the New Paltz Central School District by Ulster County for this event not to exceed \$500.00, and

WHEREAS, the New Paltz Central School District will identify Ulster County STOP DWI as a primary sponsor of the presentation, and

WHEREAS, the Legislative Programs, Education and Community Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
