FURTHER RESOLVED, that no County money be paid to the aforementioned organization until a Memorandum of Receipt signed by the principal officer and disbursing officer of such organization, agreeing to comply with the terms of this resolution, is delivered to the Ulster County Treasurer, and

FURTHER RESOLVED, that said Shadowland Theater shall render a verified account of disbursements with certified vouchers attached, refund any unused amount on or before the 31st day of December 2006, and

FURTHER RESOLVED, that the Shadowland Theater shall render a true and accurate report of its operations for the year 2006 on or before January 15, 2007 with the Clerk of the Ulster County Legislature containing a true and accurate account of all receipts and expenditures, and

FURTHER RESOLVED, that the County Auditor and/or any and all officers of the County of Ulster, their agents and representatives, shall be allowed full access upon reasonable notice and at reasonable times, to the books, papers, records and premises of the Shadowland Theater during the period that this resolution is in effect for the purpose of ascertaining the manner in which the above sum of money is being used or applied, and

FURTHER RESOLVED, that the above organization agrees to comply with all applicable Federal, State and local regulations including in particular and forbidding discrimination by such organization,
