

**Eliminating Full-Time Assistant Deputy County Executive Position  
For Ulster County – County Executive**

The Governmental Services, Environmental and Administrative Committee (Chairman Roberts and Legislators Belfiglio, Fabiano, Petit, Ronk, Richard Parete, Robert Parete, Rodriguez and Shapiro) offers the following:

WHEREAS, the County Executive launched the “Taxpayer First” Initiative on April 14, 2010, his proactive 10-point plan designed to address ongoing fiscal challenges and projected 2011 deficits, and

WHEREAS, the County Executive’s 10-point plan reduces his staff by one position with a 2010 savings for the County of \$65,404.00 (salary and fringe), and

WHEREAS, the immediate elimination of PC #1230-1040 Assistant Deputy County Executive, initiates Point 1 of the County Executive’s 10-point plan; this is a necessary action and starts the process of adopting legislation to implement the “Taxpayer First” Initiative, and

WHEREAS, the Governmental Services, Environmental and Administrative Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the position of Assistant Deputy County Executive, at \$62,392.00 annually, is hereby eliminated effective immediately upon the adoption of said resolution as follows:
