WHEREAS, the 2009 Ulster County Area Transit (UCAT) Budget included the purchase of an Automatic Vehicle Locator and Scheduling System (AVL) for the Public Transit System for the year 2009, and

WHEREAS, UCAT's bus purchase financing is dependent on both State and Federal Transit Administration 5307 Funds on an annual basis to fund transit system costs, and

WHEREAS, State Federal Transit Administration 5307 Funds are not available during the current fiscal year 2009, for the purchase of an AVL System for the Public Transit System, and

WHEREAS, the Director of Public Transportation is requesting to amend the 2009 Ulster County Operating Budget to reduce the State and Federal Aid and the County Share of the cost of the AVL System in the amount of \$300,000.00, and

WHEREAS, the Economic Development Committee has met and reviewed said funding with a majority of members voting approval, and

WHEREAS, the Ways & Means Committee has met and reviewed said funding with a majority of members voting approval, now, therefore, be it
