WHEREAS, the Hudson River Maritime Museum, Inc., will receive payment in the amount of \$2,500.00 in accordance with the specified terms in an agreement with the County of Ulster and the Hudson River Maritime Museum, Inc., and will return any unexpended funds as of December 31, 2009, along with a certified accounting of expenditures to the Commissioner of Finance, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Comptroller and/or any and all officers of the County of Ulster, their agents and representatives, shall be allowed full access upon reasonable notice and at reasonable times to the books, papers, records and premises of the Hudson River Maritime Museum, Inc., during the period that this resolution is in effect for the purpose of ascertaining the manner in which the above sum of money is being used or applied, and, be it further

RESOLVED, that the above organization agrees to comply with all applicable Federal, State and local regulations including, in particular, any forbidding discrimination by such organization, and, be it further

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement in the amount of \$2,500.00 for the maintenance and operation of the Hudson River Maritime Museum, Inc., in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
