WHEREAS, the total estimated cost of the Capital Project is \$2,656,500.00 with funding sources of 80% federal (\$2,125,200.00), 10% state (\$265,650.00), and 10% local (\$265,650.00), and

WHEREAS, the Federal Share has been approved and the Director of Public Transportation has received notification that the New York State share (\$265,650.00) is available, and
