WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works, and

WHEREAS, the Commissioner of Public Works has prepared the Highway Equipment List for year 2010, and

WHEREAS, after the review of equipment needs for the County Highways and Bridges Program, the Commissioner of Public Works requests \$475,000.00 for the year 2010 program, and

WHEREAS, the Capital Program in the amount of \$1,000,000.00 for the purchase of equipment was approved in the 2010 – 2015 Capital Program, and

WHEREAS, the original review of equipment needs for the County Highways and Bridges Program would have resulted in a request for \$1,000,000.00, the Commissioner of Public Works has reduced the equipment list sum to less than half the original request, and

WHEREAS, the equipment list reduction is based on the anticipated sharing of highway services currently being negotiated by the County and various local municipalities, and the Commissioner of Public Works may, depending upon the extent of shared services contractually agreed upon, request additional equipment at a later date, and

WHEREAS, it is now necessary to increase Capital Project No. 284 – Purchase of Highway Equipment for funding in the amount of \$475,000.00 for the year 2010, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
