WHEREAS, it is the desire of the Ulster County Legislature to keep as many of Ulster County's tax dollars reinvested in the businesses of Ulster County, and

WHEREAS, the Administrative Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Laws and Rules Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, the Ulster County Department of Purchasing will establish a "Use What We Make" policy that ensures businesses located or chartered in Ulster County that are manufacturers or providers of goods and/or services, are made aware of pending bids and are given the opportunity to supply a bid on those goods and services through the BIDNET process, and, be it further
