WHEREAS, the current 2012 budget includes \$150,000.00 to cover obligations for deductibles on claim settlements, and

WHEREAS, the current estimated costs to settle claims in 2012 are approximately \$487,000.00 with such increase due primarily to settling of significant claims from 2009-2012, and

WHEREAS, the Ulster County Insurance Officer requests that \$337,000.00 be appropriated from the Reserve Fund as provided in Section 6-n of the General Municipal Law, for payment of unanticipated judgments, actions, and claims against the County anticipated until year end, now, therefore, be it
