

Authorizing The Chairman Of The Ulster County Legislature To Execute An Inter-Municipal Agreement With The Ulster County Board Of Cooperative Educational Services To Provide Computer Information Technology Education Services To The County Employee Workforce – Department Of Information Services

The Governmental Services, Environmental and Administrative Committee (Chairman Roberts and Legislators Belfiglio, Fabiano, Petit, Ronk, Richard Parete, Robert Parete, Rodriguez and Shapiro) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Information Services, and

WHEREAS, New York State's General Municipal Law Article 5-G and Section A3-4 (Y) of the Ulster County Administrative Code provide that the Chairman of the Ulster County Legislature can enter into an inter-municipal agreement of behalf of the County of Ulster, and

WHEREAS, pursuant to General Municipal Law Section 119-n(a), the definition of a municipal corporation includes a board of cooperative educational services, and

WHEREAS, the Director of Information Services requests that the Chairman of the Ulster County Legislature be authorized to execute an Inter-Municipal Agreement, and any amendment thereto, with the Ulster County Board of Cooperative Educational Services (BOCES) to provide computer information technology education services to the County employee workforce for the period beginning July 1, 2010 and ending June 30, 2011, at the rate of \$85.00 per training hour with a sum not to exceed \$25,500.00, and

WHEREAS, the 2010-2011 training estimate is approximately 300 hours of onsite education at the rate of \$85.00 per training hour, and

WHEREAS, Ulster County BOCES will provide, on an as-needed basis for the term of this agreement, education and training instructors for the County training sessions to be held at the Ulster County Information Services Classroom, located at 25 South Manor Avenue, Kingston, New York, and

WHEREAS, the course content is to be agreed upon by the County and Ulster County BOCES, with the following education classes typically offered:
