# Authorizing The Ulster County Commissioner Of Finance To Accept A Bid On A Parcel Of County-Owned Property To Be Used For Public Use And Benefit – Department Of Finance

The Ways and Means Committee (Chairman Gerentine and Legislators Bernardo, Frey, Hansut, Harris, Maio, Maloney, Lomita, Provenzano, Rodriguez and Sheeley) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Finance, and

WHEREAS, the Ulster County Commissioner of Finance has requested permission to accept a bid for a parcel of County-owned property as hereinafter described, acquired by the County by reason of non-payment of taxes, and

WHEREAS, the Town of Plattekill, a municipal corporation, and the Plattekill Fire District wish to purchase Parcel # 51 of the 2011 Public Auction, listed as .75 acre, vacant land, in the Town of Plattekill, section, block, and lot number 107.2-2-12, which has unpaid taxes in the amount of \$1,250.57 dating back to the year 2008, and

WHEREAS, the prospective purchasers of Parcel #51 have bid \$1,250.57, the taxes due, and it is their intent to acquire this property for public use and benefit, and

WHEREAS, the Town of Plattekill and the Plattekill Fire District, by acquiring this parcel, will have access to a landlocked property they presently own, and

WHEREAS, the prospective purchasers shall be responsible for the 2010-11 school tax and all subsequent tax levies, and

WHEREAS, this conveyance constitutes a Type II action under section 4.1.5 of the County of Ulster's State Environmental Quality Review Act (SEQRA) Type II List that was adopted in Resolution No. 118 on April 20, 2010, and

WHEREAS, as per section 3 of the County's Type II List, this action does not pose a significant potential environmental impact and may be progressed as a Type II action in accordance with 6 NYCRR Part 617 of SEQRA, and

WHEREAS the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Ulster County Commissioner of Finance is hereby authorized to accept payment as follows:
