Amending The 2011 Ulster County Budget To Restore Funds For Retaining Outside Counsel – County Attorney

The Ways and Means Committee (Chairman Gerentine and Legislators Bernardo, Frey, Hansut, Harris, Maio, Maloney, Lomita, Provenzano, Rodriguez and Sheeley) offers the following:

WHEREAS, the County Attorney's Office budgeted \$10,000.00 in its 2011 Budget for retaining outside legal counsel, and

WHEREAS, due to the release of turbid water by the New York City Department of Environmental Protection (the "DEP") and the subsequent damage to Ulster County's waterways, it was necessary to expend \$5340.95 to engage a law firm with significant experience in environmental matters of this type in order to provide proper and immediate notice of the County's intent to sue the DEP in the event such releases did not immediately cease, and

WHEREAS, this expense, together with other, anticipated routine needs for outside counsel, has resulted in an inadequate balance for such expenses for the remainder of 2011, and

WHEREAS, the County Attorney's office requests that its budget be restored for the unforeseen and unexpected expense to engage counsel to protect the County's waterways, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the 2011 Ulster County Budget is hereby amended to transfer \$5341.00 from the Contingent Account to the County Attorney's budget line for outside counsel as follows:
