WHEREAS, no matching County dollars are required for these programs, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an amendment, and any additional amendments, to the above referenced contract in order to accept the additional funding in the amount of \$100.00, from the New York State Office of Mental Health for the Intensive Case Management Program, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and, be it further
