WHEREAS, a project to replace existing deteriorated roofing at the Ulster County Pool Bathhouse and roof asbestos abatement at the Courthouse in accordance with New York State Building Codes has been proposed (each a "Project;" together, the "Projects"), and

WHEREAS, the Projects' expenditures in the amount of \$250,000.00 were approved in the 2011 - 2016 Capital Program, and

WHEREAS, the Projects will prevent continued deterioration of roof and building, and

WHEREAS, the Commissioner of Public Works requests that the following Capital Project No. 339 be established for Ulster County Pool bathhouse roof replacement, and that this Project be funded in the amount of \$123,365.00; and Capital Project No. 340 be established for roof asbestos abatement at the Ulster County Courthouse, and that this Project be funded in the amount of \$126,635.00, for a total of \$250,000.00, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that Capital Project No. 339 is hereby established for the Ulster County Pool bathhouse roof replacement and is funded in the amount of \$123,365.00 and Capital Project No. 340 is hereby established for the roof asbestos abatement at the Ulster County Courthouse and is funded in the amount of \$126,635.00 for a total of \$250,000.00, and be it further
