The Criminal Justice and Safety Committee (Chairman Dart and Legislators Briggs, R.A. Parete, Zimet, Hansut, Maloney and Ronk) offers the following:

WHEREAS, the NYS Office of Homeland Security desires to operate a coordinated, combined law enforcement presence in the Hudson River, known as Operation River Guard, and

WHEREAS, the Ulster County Sheriff's Office and other units in NYS will coordinate to form a combined Law Enforcement presence on the Hudson River to ensure that vessels are in compliance with NYS and Federal rules, and

WHEREAS, Operation River Guard is to intended to prevent, respond to, minimize the danger of, and recovery from terrorist attacks, and

WHEREAS, the NYS Office of Homeland Security desires to enter into a contract with the Ulster County Sheriff's Office to provide services in relation to Operation River Guard, and

WHEREAS, the NYS Office of Homeland Security will reimburse the Ulster County Sheriff's Office for the actual overtime expense incurred in navigating the Hudson River, up to a maximum amount of \$12,754.00, as required to foster such law enforcement, and

WHEREAS, the contract (NYS Contract #T191172) is for the period July 1, 2007 through June 30, 2010, and

WHEREAS, this agreement requires no County dollars, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign the agreement, and any amendments to the agreement, for Operation River Guard with the New York State Office of Homeland Security in the amount of \$12,754.00, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and, be it further
