WHEREAS, an encumbered position of Account Clerk/Typist exists in Ulster County Department of Social Services which allows the opportunity for the Department of Social Services to review the duties and responsibilities of the position, and requests such of the Ulster County Personnel Department, and the Personnel Department has by Order and Determination #7710 determined that the encumbered position of Account Clerk/Typist (Grade 6) (Position Number 60101356) (full-time) would be appropriately reclassified to Senior Account Clerk/Typist (Grade 9) (Position Number 60101356) (full-time), and

WHEREAS, the Human Development Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Personnel Committee has met and reviewed said request with a majority of the members voting approval.
