The Law Enforcement and Public Safety Committee (Chairman Hayes and Legislators Belfiglio, Ronk, Sweeney, Briggs, Hochberg and Rodriguez) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Sheriff's Office, and

WHEREAS, the Ulster County Sheriff has been awarded a grant from the Port Authority of New York and New Jersey (Award No. 2008-GB-T8-K083), in the amount of \$165,765.00, to be used for the Port Security Grant Program, whose goal is to prevent, prepare for, respond to and recover from potential terrorist activity on waterways within the Port of Albany area, and

WHEREAS, this funding originates from the United States Department of Homeland Security and the Federal Emergency Management Agency (FEMA) and passes through the Port Authority of New York and New Jersey, and

WHEREAS, the grant requires matching funds from Ulster County of \$55,255.00, for a total project cost of \$221,020.00, and

WHEREAS, the combined grant funds and matching funds will be used to purchase equipment to assist officers in maintaining the safety and security of Ulster County and preventing potential terrorist activity on the Hudson River and to increase the County's surveillance, navigation and dive activities, and

WHEREAS, the Sheriff has requested that the Chairman of the Ulster County Legislature be authorized to execute an agreement, and any amendments to the agreement, with the Port Authority of New York and New Jersey, in the amount of \$165,765.00, for the period which begins upon the latest date of execution of the agreement by the parties and terminates on June 30, 2011, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of its members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of its members voting approval, now, therefore, be it
