Urging The New York State Assembly To Approve Assembly Bill No. A07314 Authorizing Ulster County To Continue The Additional 1% Rate Of Its Sales And Compensating Use Tax For Two More Years

Legislators Belfiglio, Bernardo, Fabiano, Felicello, Frey, Gerentine, Hansut, Harris, Hayes, Hochberg, Loughran, Maio, Maloney, Provenzano, Ronk, and Terrizzi offer the following:

WHEREAS, Resolution No. 134, "Approving Home Rule Request for Senate Bill No. S04627 and Assembly Bill No. A07314 Authorizing Ulster County to Continue the Additional 1% Rate of its Sales and Compensating Use Tax for Two More Years, was adopted by the Ulster County Legislature on May 17, 2011, and

WHEREAS, the additional 1% rate of this sales and compensating use tax is not a new tax but rather an extension that requires State approval every two years without which the County, City of Kingston and towns would lose about \$24 million in revenue, and

WHEREAS, the County's total sales tax is four percent (3% permanent and 1% temporary); the additional 1% sales tax amounts to \$21 million to the County, \$2.8 million for the City of Kingston and \$732,000.00 for the towns, and

WHEREAS, the State Legislature is due to adjourn within the next few days and it is imperative that all officials in Ulster County urge the New York State Assembly to approve an extension to the County sales tax; the New York State Senate has already approved the one percent extension, and

RESOLVED, that the Ulster County Legislature hereby urges the New York State Assembly to approve Assembly Bill No. A07314 authorizing Ulster County to continue the additional 1% rate of its Sales And Compensating Use Tax for two more years, and be it further

RESOLVED, that the Clerk of the Ulster County Legislature shall forward copies of this resolution to Governor Andrew M. Cuomo, Senate Majority Leader Dean G. Skelos, Senate Minority Leader John L.
