WHEREAS, the Belleayre Mt. Ski Center serves as the linchpin for the economy of the Rte. 28 corridor in the Central Catskills and visitors are drawn to the region by the ski center, support private sector businesses, and encourage future capital investments, and

WHEREAS, the revenue Belleayre generates is greater than the cost to operate, and any diminishment in its capacity to generate those revenues would diminish much needed revenue for the state, and

WHEREAS, the drastic staff reductions recently announced for Belleayre threaten the short term operations and the long term viability of this important economic engine, and

WHEREAS, tourism retention and growth are the best hope to maintain vibrant communities as the region struggles to balance the impacts of the forever wild preserve, the NYC watershed and a faltering national economy, and

WHEREAS, requiring Belleayre to absorb more than 34 per cent of the work force reductions for the entire Department of Environmental Conservation suggests that the importance of this facility is not recognized, and while all New York State residents understand the need for cost reductions in state operations, we urge you to recognize the extreme importance of this operation for the regions economic health, and

RESOLVED, that the Ulster County Legislature hereby requests a more equitable distribution of layoffs by reinstatement of permanent positions being cut at Belleayre Mountain, and be it further
