WHEREAS, it is essential that work commence immediately to complete the work needed during the summer months, and

WHEREAS, such work is to be reimbursed seventy-five (75) percent through the Federal Emergency Management Agency (FEMA) and twenty-five (25) percent through the State Emergency Management Office (SEMO) as allocated by FEMA and SEMO to Ulster County for this project, and

WHEREAS, the Commissioner of Public Works requests that this project be authorized to proceed and obtain reimbursement from FEMA and SEMO upon completion of the project, and

WHEREAS, the Governmental Services, Environmental and Administrative Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
