WHEREAS, the Ulster County Sheriff is requesting that the Chairman of the Ulster County Legislature be authorized to execute an Agreement (Agreement No. N00164LE0091-09), and any future amendments thereto, with the Department of the Navy, Naval Surface Warfare Center, for the period May 8, 2009 through May 8, 2010, and

WHEREAS, the Naval Surface Warfare Center will loan the Ulster County Sheriff’s Office three night vision goggles for a total of \$900.00 (3 goggles @ \$300.00 each per year), and

WHEREAS, this equipment will aid the Sheriff’s personnel with increased visibility in no-light or low-light conditions, and

WHEREAS, the Criminal Justice and Safety Committee has been met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an Agreement (Agreement No. N00164LE0091-09), and any future amendments thereto, with the Department of the Navy, Naval Surface Warfare Center, for the period May 8, 2009 through May 8, 2010, and, be it further
