WHEREAS, the Public Health Director requests that the Chairman of the Ulster County Legislature be authorized to execute a contract (Contract No. C-024921) in the amount of \$254,251.00 with the New York State Department of Health to renew the Drinking Water Enhancement (DWE) Program, for the period April 1, 2009 through March 31, 2010, and

WHEREAS, the DWE Program was established to increase the capacity of the Department of Health in its oversight and implementation of the public drinking water supply program; these funds assist in the implementation of the Public Water System Supervision Program (PWSS) which consists of the following workplan:

- 1. Investigations/Enforcement/Emergency Response;
- 2. Assure Compliance with Part 5 of the State Sanitary Code (SSC);
- 3. Full Utilization of the Safe Drinking Water Information System (SDWIS) and proficient use of SDWIS add-ons;
- 4. Enhance the safety of drinking water at non-public water systems;
- 5. Implement New Safe Drinking Water Act Programs and Regulations;
- 6. Staff Development; and
- 7. Reporting
