WHEREAS, pursuant to Resolution No. 68, dated March 11, 2009, the Ulster County Legislature approved amending Capital Project No. 286 to include the upgrade of the Nursing Lab at Ulster County Community College for a total cost of \$425,000.00 (\$363,974.00 for construction, \$22,389.00 for equipment and furnishings and \$38,637.00 for architectural and engineering fees), and

WHEREAS, pursuant to Resolution No. 317, dated November 10, 2009, the Ulster County Legislature approved amending Capital Project No. 286 to include the transfer of funds in the amount of \$67,611.00 from construction to nursing lab equipment which left \$296,363 in the construction line,

WHEREAS, the construction costs (\$183,487.00 awarded to date, plus \$80,000.00 estimated for HVAC work) total \$263,487.00,

WHEREAS, the HVAC is an integral part of construction and does not change the scope of the project or environmental impact, but should be accounted for separately according to the county's Capital Project Procedures,

WHEREAS, the Community College Board of Trustees recommends the transfer of funds in the amount of \$86,385.00 from construction to a new line HVAC, and

WHEREAS, the Legislative Programs, Education and Community Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Capital Projects Oversight Committee for UCCC Capital Projects has met, reviewed said request and supports the project, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
