The Public Works and Capital Projects Committee (Chairman Fabiano and Legislators Felicello, Maloney, Roberts, Hochberg, Loughran and Provenzano) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works, and

WHEREAS, Resolution No. 165 of April 11, 2002 approved an agreement with the City of Kingston (County Contract #C02-00559, the "Agreement"), which authorized the County to provide infrastructure improvements, including water and sewer lines to the City property located adjacent to the then new Law Enforcement Facility at 380 Boulevard, Kingston, New York, and

WHEREAS, the County encountered unanticipated difficulties related to construction of the water and sewer lines, and

WHEREAS, Resolution No. 368 of November 14, 2007, approved a modification ("Amendment No. 1") to the Agreement, pursuant to which the City waived the County's obligation related to sewer and water lines in exchange for the County providing canopies over the Transfer Station dumpsters, at an estimated cost of \$75,000.00, and repaving/repairing the then existing paved area at the Transfer Station, and

WHEREAS, the County and the City of Kingston now wish to further modify and to terminate the original Agreement by executing Amendment No. 2, pursuant to which the County shall pay to the City of Kingston a lump sum amount of \$75,000.00 as full and final compensation for any and all work included in or contemplated by the original Agreement and/or Amendment No. 1, and

WHEREAS, in exchange for such full and final payment, the City will release the County from any and all further obligations relative to the Agreement and/or Amendment No. 1, and/or Amendment No. 2, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it
