WHEREAS, the Ulster County Resource Recovery Agency (UCRRA) is a public benefit corporation that was formed for the purpose of developing, financing, and implementing a comprehensive Countywide solid waste management program, and

WHEREAS, the UCRRA has had significant financial difficulties in the past few years, including the accumulation of an estimated \$40 million dollars in debt, and

WHEREAS, the UCRRA has only recently begun a process to reform its financial operations and still has significant problems inherited from previous administrations, and

WHEREAS, the Ulster County Legislature is committed to accountability in all aspects of government and taxpayer obligation, and

WHEREAS, the Ulster County Legislature is obligated to pay the debt of the UCRRA, regardless of whether it is operational or not, and

WHEREAS, the New York State Comptroller's Office is a resource to help understand financial matters, review performance of governing entities and public benefit corporations, and uncover financial mismanagement, and

WHEREAS, the UCRRA is considered a class C public authority within the State of New York, and

WHEREAS, the New York State Comptroller's Office has not yet had the opportunity to ever audit the Ulster County Resource Recovery Agency, and

WHEREAS, the Environmental Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Ulster County Legislature calls upon the New York State Comptroller's Office to audit the financial condition of the UCRRA and present its findings to the legislature; and
