

**Authorizing The Chairman Of The Ulster County Legislature To Execute An Inter-Municipal Agreement With The County Of Oneida For Security For Ulster County Inmates Boarded At Central New York State Psychiatric Center – Sheriff's Office**

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Briggs, R.A. Parete, Zimet, Hansut, Maloney and Ronk) offers the following:

WHEREAS, the Ulster County Sheriff is requesting that the Chairman of the Ulster County Legislature be authorized to execute an agreement with Oneida County for the security of Ulster County inmates with psychiatric problems, and

WHEREAS, these inmates are boarded out to the Central New York Psychiatric Center and through the agreement with Oneida County Sheriff's Offices, they will provide the necessary security at a cost of \$140.00 per day, per inmate, and

WHEREAS, the term of the agreement is January 1, 2009 through December 31, 2009, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to enter into an agreement with Oneida County for the security of Ulster County inmates boarded out to Central New York Psychiatric Center at a cost of \$140.00 per inmate, per day, for the term of the agreement January 1, 2009 through December 31, 2009, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney,

and moves its adoption.
