The Law Enforcement and Public Safety Committee (Chairman Hayes and Legislators Belfiglio, Ronk, Sweeney, Briggs, Hochberg, and Rodriquez) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Probation, and

WHEREAS, the Director of the Ulster County Department of Probation has requested that the Chairman of the Ulster County Legislature be authorized to execute a contract (NYS Comptroller's No. C490000; Project No. RE09-1028-D00) with the New York State Division of Criminal Justice Services, in the amount of \$100,000.00, for continuation of a County Re-Entry Task Force and establishment of an enhanced services program, for the period starting October 1, 2009 and ending September 30, 2010, and

WHEREAS, the grant program's objective is to support the continuation of a County Re-entry Task Force and to enhance the process of returning formerly incarcerated individuals back to the community using evidence-based practices, and

WHEREAS, there is no County match required for this grant program, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature be authorized to execute a contract (NYS Comptroller's No. C490000), and any amendments thereto, with the New York State Division of Criminal Justice Services, in the amount of \$100,000.00, for the continuation of a County Re-Entry Task Force and the creation of an enhanced services program, for the period October 1, 2009 through September 30, 2010, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and be it further
