The Criminal Justice and Safety Committee (Chairman Dart and Legislators Briggs, R.A. Parete, Zimet, Hansut, Maloney and Ronk) offers the following:

WHEREAS, pursuant to Section 504 of the New York State Corrections Law, counties agree to receive and keep in their respective jails, prisoners from each other's counties that they cannot accommodate, and

WHEREAS, Section A3-4(Y) of the Ulster County Administrative Code provides that the Chairman of the Ulster County Legislature, when supported by resolution, can enter into an inter-municipal agreement on behalf of the County of Ulster, and

WHEREAS, the County of Putnam wishes to house inmates in the Ulster County Jail at the rate of \$95.00 per day per inmate for the period of April 1, 2009 through March 31, 2010, and

WHEREAS, the Sheriff requests that the Chairman of the Ulster County Legislature be authorized to execute on behalf of the County, an inter-municipal agreement with the County of Putnam for boarding in inmates in the Ulster County Law Enforcement Center, and

WHEREAS, the Criminal Justice and Safety Committee has been met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute on behalf of the County, an inter-municipal agreement with the County of Putnam to board prisoners in the Ulster County Law Enforcement Center, for the period April 1, 2009 through March 31, 2010, at a rate of \$95.00 per inmate, per day, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
