WHEREAS, the Ulster County Board of Cooperative Educational Services (BOCES) has requested a Deputy Sheriff be assigned as a School Resource Officer (SRO) at the BOCES building in Port Ewen, and

WHEREAS, BOCES will reimburse Ulster County 100% of the salary plus benefits of the Deputy Sheriff assigned as the SRO, and

WHEREAS, the salary plus benefits amounts to \$83,185.77 and shall be paid in equal quarterly installments, and

WHEREAS, the Ulster County Sheriff has requested that the Chairman of the Ulster County Legislature be authorized to execute an agreement with BOCES for a SRO for the period July 1, 2010 through June 30, 2011, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement with BOCES to provide a School Resource Officer to the Port Ewen BOCES, for the one year period beginning July 1, 2010 through June 30, 2011, as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the Ulster County Attorney,
