WHEREAS, the cost of salary plus benefits totals \$66,585.00 and the reimbursement of this amount by BOCES to the County will be paid in equal quarterly installments, and

WHERAS, the term of the agreement shall be July 1, 2011 through June 30, 2012, and

WHEREAS, the Government Services and Administration Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign an agreement with the Ulster County Board of Cooperative Educational Services (BOCES) to provide a Deputy Sheriff to serve as a School Resource Officer to BOCES for the term July 1, 2011 through June 30, 2012, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
