The Governmental Services and Administration Committee (Chairman Roberts and Legislators Belfiglio, Fabiano, Ronk, Robert Parete, Madsen and Rodriguez) and Co-Sponsors: The Law Enforcement and Public Safety Committee (Chairman Hayes and Legislators Belfiglio, Ronk, Sweeney, Briggs, Hochberg, and Rodriguez) offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Sheriff, and

WHEREAS, the Town of Fallsburg Police Department desires an in-car communication system for the purpose of dispatch and data exchange, and

WHEREAS, the Ulster County Sheriff's Office has the capacity to provide this service to vehicles owned and operated by other agencies through its computer server using "packet clusters," and

~~WHEREAS, the term of this agreement is January 1, 2011 through December 31, 2011, and~~

WHEREAS, the contract provides for an annual payment of \$1200.00 by the Town of Fallsburg to the County in exchange for the use of the communication system in ten vehicles, and

WHEREAS, the Government Services and Administration Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign an agreement with the Town of Fallsburg to provide in-car communication service, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
