WHEREAS, the County Executive has appointed Dr. Edward J. Brown as Commissioner of Mental Health, pending review of the IOCC, and

WHEREAS, Dr. Edward J. Brown's credentials have been reviewed by the IOCC and per their letter dated February 3, 2009, they have certified that Dr. Brown's education and experience meet State requirements thus, he is qualified to serve in the above position, and

WHEREAS, the Health Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
