WHEREAS, the Ulster County Charter, Article V, Section C-41, mandates that the department head for the Ulster County Department of Health shall be a licensed physician with experience in public health, and

WHEREAS, Section A2-5 (8) of the Administrative Code dictates that the Ulster County Legislature shall have the power "...to establish salary ranges within which the appointing authority shall have discretion to set the actual salary within the range," and

WHEREAS, it is hereby proposed that an annual salary range of \$125,000.00 to \$175,000.00 be established for the position of Public Health Director for the Ulster County Department of Health, commensurate with the qualifications and duties of this position, and

WHEREAS, the Health Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Ulster County Legislature hereby establishes an annual salary range of \$125,000.00 to \$175,000.00 for the position of Public Health Director for the Ulster County Department of Health,

and moves its adoption.
